

ASSET PURCHASE AGREEMENT

THIS AGREEMENT made and entered into on this the 28th day of September, 2023 by and between BROADSOUTH COMMUNICATIONS, INC., an Alabama Corporation hereinafter referred to as "Buyer" and WESTBURG BROADCASTING ALABAMA, LLC, (ET AL) a Washington State Limited Liability Company, hereinafter referred to as "Seller".

WHEREAS the Buyer and Seller hereby agree to enter into this agreement to provide that the Seller shall transfer all ownership interest to the buyer related to radio stations listed herewith which includes all assets, broadcasting towers, transmitters, studio equipment, leasehold interests, contracts, agreements, employees, employee agreements, licenses, accounts receivable, company records, trademarks, logos and all other rights and property not otherwise specified. A listing of equipment is attached and labeled as "Exhibit A".

On the day and date of closing, the seller agrees to pay or have paid all current accounts payable due creditors, contractors, employees and shall retain cash remaining in Seller's bank accounts after the payables are satisfied.

AND WHEREAS the Seller owns and operates radio broadcasting stations WINL-FM (Linden, Alabama), and WZMJ-FM (Demopolis, Alabama) which are licensed by the Federal Communications Commission, this agreement is subject to specific "Change of Control" requirements and subsequent approval by the Federal Communication Commission (FCC), which if denied, this agreement becomes null and void. This agreement does not apply to radio station WXAL-AM (Demopolis, AL) which shall be surrendered to the Federal Communications Commission prior to the closing.

IN CONSIDERATION OF Twenty Five Thousand Dollars (\$25,000) in cash due to Seller from Buyer on the day and date of closing, this agreement shall be consummated. The day and date of closing shall be determined based on the aforementioned approval by the Federal Communications which is anticipated to be on or before December 31, 2023.

THIS AGREEMENT provides that the Buyer and Seller do agree to make the proper provisions and take the proper steps to close this transaction on or before December 31, 2023 and hereby agree to share equally in the expenses to make the proper filings with the Federal Communications Communication (FCC) through a qualified attorney and qualified engineering consultants who are required to prepare certain engineering documents to be approved by the FCC. The Buyer shall bare its expense individually for legal and accounting representation not related to FCC approval and the Seller shall bare its own expense individually for legal and accounting representation not related to FCC approval.

THE SELLER hereby warrants that there are no outstanding liens, judgements or other liabilities outstanding that have not been fully disclosed to the Buyer.
