Shapiro controls 38.71% of the voting interests in, and is the controlling single majority shareholder of, Madison Halsted LLC in his personal and individual capacity. *See Review of the Commission’s Regulations Governing Attribution Of Broadcast and Cable/MDS Interests*, MM Docket Nos. 94-150 et al., Order, FCC 01-353 (2001). Post-closing, Mr. Shapiro’s 38.71% voting interest will be directly held by the Hills Family Trust, of which Mr. Shapiro is trustee. Mr. Shapiro will continue to hold the power to vote an additional 32.29% of the voting interests in Madison Halsted LLC in his capacity as trustee or co-trustee of trusts established for the benefit of certain members of his family.

<sup>3</sup> Sean Scott holds the power to vote 29.8% of the voting interests in Madison Halsted LLC in his capacity as trustee or co-trustee of trusts established for the benefit of certain members of the family of Norman H. Shapiro. Because Messrs. Shapiro and Scott and Ms. Lilli Scheye serve as co-trustees of certain of the trusts and collectively exercise the voting rights of those trusts the aggregate voting interests reported in the table above exceed 100%.
