

## Description of the Transaction

The instant application requests Commission consent to the *pro forma* transfer of control of ION Media Boston License, LLC; ION Media License Company, LLC; and ION Television License, LLC (collectively, the “Licensees”).<sup>1</sup> The Licensees are wholly owned and wholly controlled indirect subsidiaries of The E.W. Scripps Company (“Scripps”). The *pro forma* transfer of control concerns a corporate reorganization that will involve near-simultaneous transfers that will result in ION Media Stations, Inc. (“IMS”) becoming the direct parent entity of each of the Licensees.<sup>2</sup> Specifically, ION Media Networks, Inc., which is a direct or indirect parent to each of the Licensees, will merge with IMS. IMS will be the surviving entity of that merger.<sup>3</sup>

The applicants certify that the use of the short form application is appropriate for this internal reorganization. The Commission last approved the qualifications of the entities with the existing interests in the Licensees in FCC file number BTCCDT-20201013AACH, *et seq.* (ION Media Boston, LLC); BTCCDT-20201013ABV, *et seq.* (ION Media License Company, LLC); and BTCCDT-20201013AAO, *et seq.* (ION Television License, LLC).

Scripps, the ultimate parent entity of the parties to this application, through wholly owned subsidiaries, controls the licenses for the following full-service broadcast television stations:


