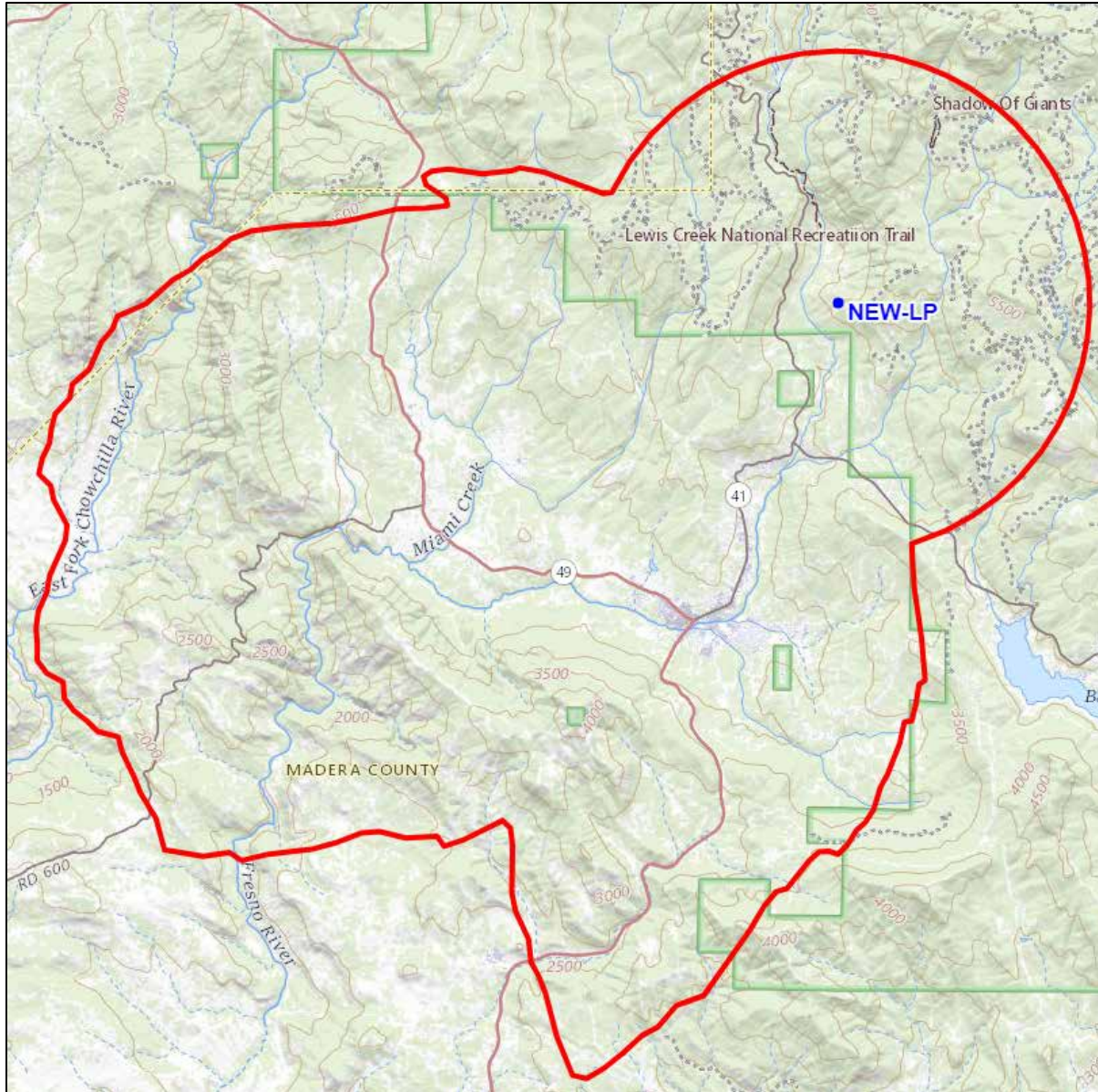

## **EDUCATIONAL STATEMENT**

Mountain Community Radio is a nonprofit educational corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Educational Corporation Law for charitable purposes.

Mountain Community Radio was incorporated on July 20, 2023 in the state of California. The educational mission of Mountain Community Radio is to provide public safety information to the residents in the Sierra Nevada foothills of Eastern Madera County and those 3.7 million travelers that annually pass through this area to Yosemite National Park.

Each year this unincorporated region faces countless threats from wildland fires, flooding, severe weather, and more.

Due to the simple facts that this area has NO local newspaper and NO English-speaking local AM or FM radio station, Mountain Community Radio was incorporated to provide public information for this rural community, especially when emergencies happen without warning. Vital information is essential and, combined with planning and emergency preparedness, can save lives. Thus, the mission of Mountain Community Radio is to educate the public, not only on what to do in an emergency situation, but, also what resources are available and how to be better prepared, if and when, a situation occurs.

### **EDUCATIONAL OBJECTIVES**

Mountain Community Radio shall keep the residents in touch with current local issues, broadcasting 24 hours a day, 7 days a week, 365 days a year, as well as online on its website and through social media.

The proposed low power FM station will advance Mountain Community Radio's educational program objectives by broadcasting:

- + a community calendar of local events
- + local weather, with public warnings and alerts during inclement weather
- + local news and current events
- + music and entertainment
- + valuable safety tips to help the public be better prepared for whatever comes our way
- + web links for public information on local, state, tribal, and national emergency services
- + how to protect your home and property from wildfires
- + informational programs on community resources and how to access those specific resources during an emergency situation
- + information on how to get simple-to-use emergency apps on cell phones for Madera County Alert System, California Earthquake Early Warning, etc
- + guides to prepare for hazards and severe weather alerts to keep loved ones safe
- + how to plan and prepare for future events, such as major incidents or disasters for a possible shelter-in-place with adequate supplies of food, water, fuel, medical supplies, blankets, flashlight, animal care, etc
- + special services available for people with disabilities, older adults, children, limited English proficiency, and transportation disadvantaged
- + what to do in a power outage

- + how to make a "go-bag" and a list of important documents, supplies needed in the event of an evacuation or future incident
- + public health concerns in another pandemic
- + all public safety information in a calm, effective manner to be understood, consumable and actionable by the whole community

Examples of planned educational programs to be provided:

- + host educational training and informational sessions with community partners, such as CALFire, Red Cross, Madera County Sheriff, CALTrans, PG&E, Camarena Health, Hillside Water, etc
- + interviews and panel discussions with local emergency service experts on ways to prepare and stay safe in different situations
- + live broadcasts from local studio with community leaders
- + public service announcements
