FM Radio Station Approved At Xenia

XENIA — Harry B. Miller, a native of Wapakoneta, reported the Federal Communications Commission has approved his application for a construction permit to set up a FM radio station at 30½ N. Detroit St.

Miller, owner-manager of the station, said he will start immediately to install the equipment, and he added the station probably will be on the air officially in about three weeks. It will go on the air for test purposes earlier than that.

The call letters will be WHBM (the initials of the station owner) and the station will broadcast at 103.9 megacycles on the FM dial. According to present plans, the station will go on the air each day at 6 a. m. and sign off at midnight.

Miller said the station will specialize in local sports and news and "good" music. "And I mean good music, no rock-and-roll stuff," he said.

CONSTITUTION AND BY LAWS

CONSTITUTION

PREAMBLE

The purpose of this Organization is to promote interest in Amateur Radio, assist all persons interested in same by helping them to learn Radio Code and Theory and obtain a License to operate an Amateur Radio Station. Also to take part in Emergency Radio Communications, support our county Office of Emergency Management, cooperate at all times with our County Emergency Coordinator (ARES) and to keep prepared at all times to furnish Emergency Communications in times of any disaster.

ARTICLE I

The name of this Organization shall be " The Clinton County Amateur Radio Association ", " C.C.A.R.A. " here in referred to as " ASSOCIATION ".

ARTICLE II

Anyone interested in Amateur Radio is eligible to become a member of the Association.

ARTICLE III

Officers

The Officers shall consist of a President, Vice President, Technical Vice President(s), Secretary, Treasurer, and Directors. These are the Elective Offices. They shall hold Office from January 1st through December 31st, except Directors as noted in Article XIII of the BY LAWS. Only members of the Association holding Amateur Licenses are eligible to hold office.

ARTICLE IV

Elections

Election shall be by ballot, and majority of votes cast by members of the Association shall be necessary to elect Officers or vote upon questions brought before the Association. The process of Electing Officers shall be completed by the end of the December Annual meeting.

ARTICLE V

Standing Committees

The President shall appoint the Chairman of such Standing Committees, composed of three members. The Chairman shall appoint two additional members to assist him as designated in the BY-LAWS.

Definition

Majority:

Whenever used in this CONSTITUTION or BY LAWS shall mean any number more than half of the members present.

THE CLINTON COUNTY AMATEUR RADIO ASSOCIATION BY LAWS

ARTICLE I

Quorum

Twenty percent of the Association's voting members shall be present to constitute a Quorum. A Quorum must be present to transact Association business.

ARTICLE II

Dues

The Dues of the Association shall be established by vote of the General Membership.

It shall be the duty of the Treasurer to collect and account for all dues at the times specified.

ARTICLE III

Membership

Membership Committee :

A Chairman on Membership shall be appointed by the President. The Chairman shall select two assistants. It will be the duty of this committee to contact all Amateurs in this area and solicit their membership.

Classes of Membership :

The Clinton County Amateur Radio Association shall have two (2) classes of membership. Membership shall be granted only after application has been made and appropriate dues paid.

Classes of membership are as follows:

1. Full Membership :

Any Licensed Amateur may apply for a Full Membership in the Clinton County Amateur Radio Association. A Full Membership shall confer full voting rights on all business that may come before any General Membership meeting of the Association.

2. Associate Membership :

Any person interested in Amateur Radio may apply for an Associate Membership in the Clinton County Amateur Radio Association. An Associate member will have all the privileges of the Full Membership except for voting rights on Association business.

Family Membership :

(a) Any C.C.A.R.A. member who has family members wanting to join the Association may apply for additional memberships at Family Membership Dues rates.

(b) A family is considered as one (1) household. Children who are attending school out of town are still considered part of the "one (1) household".

ARTICLE IV

Meetings

Meetings shall be held the first Thursday of each month at our designated Association Headquarters. Members will be advised in advance of any change in time or place of meetings.

ARTICLE V

Responsibilities of the Secretary and Treasurer

The Secretary shall transcribe the minutes of each meeting. Said minutes shall be transcribed in a suitable volume. Upon completion of this volume, it shall become the property of the Association to be preserved by the Secretary.

The Treasurer shall pay the debts of the Association only after obtaining authorization from the Association. All checks will be signed by the Treasurer.

ARTICLE VI

Vacancies

The President shall have the right to appoint any Full Member to fill a vacancy in any office until the next Annual meeting.

ARTICLE VII

Special Meetings

The President shall have the right to call such Special Meetings as necessary to conduct the business of the Association.

ARTICLE VIII

Treasurer's Report

The duly elected Treasurer shall make monthly reports of the financial condition of the Association at its regular monthly meetings.

ARTICLE IX

Association Room

The President, with the approval of the membership, shall select a meeting place for the Association.

ARTICLE X

Amendments

This Constitution and By-Laws may be amended at any time as follows:

1. The proposed amendments must be brought before a Quorum of the Association.
2. When brought before the Quorum, they must pass by a two-thirds vote of the Quorum.
3. The proposed amendments must be brought before and passed by a Quorum of the Association a minimum of two (2) times. This requirement is only satisfied when the text of the proposed amendments is the same at both readings.

ARTICLE XI

Honorary Membership

Honorary Membership, without payment of dues, may be bestowed by unanimous vote of the members present at a regularly scheduled monthly meeting. This Honorarium will confer Full Membership privileges.

ARTICLE XII

Technical Vice President(s)

The Technical Vice President(s) (Technical V.P.(s)) must be a Full Member holding a Technician class license or above. The Technical V.P.(s) shall be in direct control of the Association's Amateur Radio Repeater(s) and associated equipment. The Technical V.P.(s) shall be in charge of and responsible for the day to day operation and maintenance/repair of said equipments. The Technical V.P.(s) may select, at there discretion, additional licensed club members holding a Technician License or above to act as trustees/control operators in there absence and to aid them in any maintenance or repair. The General Membership shall allocate a budget from which the Technical V.P. may freely draw to facilitate day to day operation of the repeater equipments.

Association members shall be responsible to the Technical V.P.(s) in their operation of said repeater(s).

ARTICLE XIII

BOARD OF DIRECTORS

Section 1 : Powers : The business of the Association shall be managed by the Board of Directors who may exercise all of the powers of the Association as provided by these BY LAWS.

Section 2 : Composition of the Board : The Board of Directors Shall consist of four Directors elected by the membership and the elected offices of President, Vice President, Secretary, Treasurer, and Technical Vice President(s). All members of the Board shall have an equal vote in the conduct of the Association business.

Section 3 : Elections : Directors shall be elected for a term of two years at the annual meeting. Election shall be in two groups of two Directors with staggered terms. Officers shall be elected for one year terms as specified in the constitution.

Section 4 : Tenure : Except as otherwise provided, Directors shall hold office until the next annual meeting of the Association and thereafter until their successors are chosen and qualified. Any Director may resign by delivering a written resignation to the Association at its principle office or to the President or Secretary. Such resignation shall be effective upon receipt unless it is specified to be effective at some other time or upon the happening of some other event.

Section 5 : Removal : A member of the Board of Directors may be removed from office:

(a) With or without cause by a majority vote of the eligible voting members of the General Membership.

(b) A director may be removed for cause only after a reasonable notice and opportunity to be heard before the body proposing to remove them.

Section 6 : Meetings : The Board of Directors shall meet a minimum of once per calendar quarter (four times per year). All board members shall be notified in advance of time, date and location of the meeting. A report of these meetings will be made to the General Membership at the next regular Association monthly meeting.

Special meetings of the Board of Directors may be held at any time and place designated in a call by the President, Treasurer or two or more members of the Board. A report of these meetings will be made to the General Membership at the next regular Association monthly meeting.

Section 7 : Quorum : At any meeting of the Directors, a majority of the Directors then in office shall constitute a Quorum. At any meeting of the Board of Directors, a majority of the Board of Directors then in office shall constitute a Quorum. When less than a quorum is present, the meeting may be adjourned from time to time without further notice.

Section 8 : Action at a Meeting : During any meeting of the Directors at which a quorum is present a majority vote of the Directors shall be sufficient to decide such matters that may come before them. The General Membership shall allocate a budget from which the Directors may freely draw. Any financial matter which would exceed this established budget must be taken before The Board Of Directors.

The minutes of the September 3rd meeting, were read. Dawn Yeagley moved to accept the minutes, seconded by Jim Eicher, motion carried. The Treasurer's Report showed a beginning balance of \$1630.46. Expenses were Telephone ~~\$24.50~~ \$20.92 leaving a balance on hand September 30 of \$1609.54. Bob Flint moved to accept the Treasurer's Report, seconded by Jim Eicher, motion carried.

Paul Helbringer gave the Repeater Report. Helbringer, Yeagley & Boyle found a bad coax connection & a corrosion problem at the antenna base. They hope this corrects the noise problem. The 440 crystals are in but the machine is still in cross band operation.

The Corn Festival operations went quite well. Could have used more help. They were able to assist an emergency vehicle through the parade.

Helbringer presented a bill for \$79.50 for the 440 crystals and installation of the crystals by the factory. Dawn Yeagley moved to pay the bill, seconded by Jim Ranz, motion carried.

Helbringer reported that he has not been able to contact Dave Yockey for a program at the Christmas Party on December 3rd.

The club officer election was discussed. An election chairman volunteer is needed. President Mike will try to obtain one before the next meeting. Helbringer volunteered to print the mail out ballot cards.

It was reported that nothing has been done by the Ohio Repeater Council to date to correct the Grove City repeater interference problem. Boyle will check with the Repeater Council when he requests permanent coordination for our 440 Repeater.

Helbringer reported the club was not invited to participate in the City Hall open House.

The proposed Club Constitution was brought up for discussion & action. Boyle read through the Constitution & some minor changes were made. Bob Moore moved to approve the constitution as corrected, seconded by Eric Wallace, motion carried.

Robert Moore moved that the the Family member dues be set at \$10.00 plus an additional family \$5.00 for each additional family member, seconded by Jim Ranz, Motion Carried.

Eric Wallace moved that additional family members be given the Auto patch privilege at \$5.00 if no additional speed dial is requested, seconded by Bob Moore, Motion Carried.

Upon passage of the Constitution, Mike Boyle declared the Directors position open and appointed the following members to serve as directors as indicated: Jim Eicher, 1 year term to expire 1992; Don Canby 1 year, term to expire 1992; Jim Ranz 2 year, term to expire 1993; Dennis Creech 2 year, term to expire 1993. All term expirations are December 31 of the indicated year. A vote to approve the directors, without a motion, was carried.

Bob Moore moved to allow the ^{Family VP} ~~Board~~ a temporary budget of \$100.00 for the remainder of the year, seconded by Dana Dunsmuth, Motion Carried.

With no further business, Jim Eicher moved to adjourn, seconded by Jim Ranz, Motion Carried.

CONSTITUTION

PREAMBLE

The purpose of this organization is to promote interest in Amateur Radio, assist all persons interested in same by helping them to learn Radio Theory and obtain an FCC License to operate an Amateur Radio Station. Also to take part in Emergency Radio Communications, support our county Office of Emergency Management, cooperate at all times with our Emergency Coordinator (ARES) and to keep prepared at all times to furnish Emergency Communications in times of any disaster.

ARTICLE I

The name of the organization shall be "The Clinton County Amateur Radio Association."

ARTICLE II

Anyone interested in Amateur Radio is eligible to become a member of the Association.

ARTICLE III

Officers

The officers shall consist of a President, Vice President, Technical Vice President(s), Secretary, Treasurer, and Directors. These are the Elective offices. They shall hold office from January 1st through December 31-st, except Directors as noted in Article XIII of the BY LAWS. Only members of the Association holding Amateur Licenses are eligible to hold office.

ARTICLE IV

Election shall be by ballot, and a majority of votes cast by members of the Association shall be necessary to elect officers or vote upon questions brought before the Association. The process of Electing Officers shall be completed by the end of the December Annual meeting.

Majority:

ARTICLE I

Quorum

Twenty percent of the Associations voting members to include 3 officers shall be present to constitute a Quorum. A quorum must be present to transact Association business.

ARTICLE II

The Dues of the Association shall be established by vote of the General Membership. Dues will be broken down into two (2) categories, SINGLE Membership Dues and FAMILY Membership Dues. It shall be the duty of the treasurer to collect and account for all dues at the times specified.

1. SINGLE Membership Dues: Dues payed for a "One individual or person (Full Membership or Associate Membership)
2. FAMILY Membership: Dues payed for a Family
 - A. Any C.C.A.R.A. member who has family members wanting to join the Association may apply for additional memberships at Family Membership Dues rate. A family is considered as one (1) household. Children who are attending school out of town are still considered to be part of one (1) household.

ARTICLE III

Membership

Membership Committee:

A Chairman on Membership shall be appointed by the President. The Chairman shall select two assistants. It will be the duty of this committee to contact all Amateurs in this area and solicit their membership.

Classes of Membership:

The Treasurer of this Association shall not pay any debts of the Association without first obtaining the direct authorization and vote of the Association. All checks will be signed by either the Treasurer or the President.

ARTICLE VI

Vacancies

The President shall have the right to declare a vacancy in any office and shall have the right to appoint any licensed member to fill such vacancy until the next Annual Meeting.

ARTICLE VII

Special Meetings

The President shall have the right to call such Special Meetings as he/she deems necessary to conduct the business of the Association.

ARTICLE VIII

Treasurer's Report

The duly elected Treasurer shall make monthly reports of the financial condition of the Association at its regular monthly meetings.

ARTICLE IX

Association Room

The President, with approval of the membership shall select a place of meeting for the Association.

ARTICLE X

Amendments

This CONSTITUTION and BY LAWS may be amended at any time as follows:

1. The proposed amendments must be brought before a Quorum of the Association.
2. When brought before a Quorum, they must pass by a two-thirds vote of the Quorum.
3. The proposed amendments must be brought before and passed by a quorum of the association a minimum of two (2) times. This requirement is only satisfied when the text of the proposed amendments is the same at both readings.

ARTICLE XI

Honorary Membership

Honorary Life Membership status: Member for Life without paying any dues. Members may obtain the Honorary Membership status by the following:

1. Must be nominated for Honorary Life Membership status.
2. Motion to approve and Second at a general membership meeting with a quorum in attendance..
3. Motion passes by majority vote.

ARTICLE XII

Technical Vice President(s)

The Technical Vice President(s) (Technical V.P.(s)) must be a Licensed Amateur Radio Operator holding a Technician Class license or above. The Technical V.P.(s) shall be in direct control of the Associations Amateur Radio Repeater(s) and associated equipment. The Technical V.P.(s) shall be in charge of and responsible for the day to day operation and maintenance/repair of said equipment. The Technical V.P.(s) may select, at their discretion, additional licensed club members holding a Technician license or above to act as trustees/control operators in there absence and to aid them in any maintenance or repair. The General Membership shall allocate a budget from which the Technical V.P.(s) may freely draw to facilitate day to day operation of the repeater(s) and associated equipment.

Association members shall be responsible to the Technical V.P.(s) in their operation of said repeater(s).

ARTICLE XIII

Board of Directors

Section 1

Powers: The business of the Association shall be managed by the Board of Directors who may exercise all of the powers of the Association as provided by these BY LAWS.

Section 2:

Composition of the Board: The Board of Directors shall consist of four (4) directors elected by the membership and the elected offices of President, Vice President, Secretary, Treasurer and Technical Vice President(s). All members of the Board shall have an equal vote in the conduct of the Association business.

Section 3:

Elections: Directors shall be elected for a term of two (2) years at the annual meeting. Election shall be in two groups of two directors with staggered terms. Officers shall be elected for one year terms as specified in the constitution.

Section 4:

Tenure: Except as otherwise provided, Directors shall hold office until the next annual meeting of the Association and thereafter until their successors are chosen and qualified. Any director may resign by delivering written resignation to the Association at its principle office or to the President or Secretary. Such resignation shall be effective upon receipt unless it is specified to be effective at some other time or upon the happening of some other event.

Section 5:

Removal: A member of the Board of Directors may be removed from office with or without cause by a majority vote of the eligible voting members of the General Membership. A director may be removed for cause only after a reasonable notice and opportunity to be heard before the body proposing to remove them.

Section 6:

Meetings: The board of Directors shall meet a minimum of once per calendar quarter (four times per year). All board members shall be notified in advance of the time, date and location of the meeting. A report of these meetings will be made to the General Membership at the regular Association monthly meeting.

Section 7:

Quorum: At any meeting of the directors, a majority of the directors then in office shall constitute a Quorum. When less than a quorum is present, the meeting may be adjourned from time to time without further notice.

Section 8:

Action at a Meeting: During any meeting of the Directors at which a quorum is present a majority vote of the Directors shall be sufficient to decide such matters that may come before them. Any financial matter must be taken before the General Membership.

ARTICLE XIV

Repeater Trustee

The C.C.A.R.A. Repeater Trustee(s) will be designated by the Association. This individual(s) must have a valid Amateur Radio Operators License and be a member in good standing with C.C.A.R.A. The Repeater Trustee(s) may elect to utilize their own call sign on the repeater(s) or utilize the Association's Club Call. The call sign is utilized for identification purposes.

The Repeater Trustee(s) is/are in charge of the Associations repeaters. The Repeater Trustee(s) is/are responsible to make sure communications on the Associations repeaters comply with FCC Part 97. Infractions of the rules will be noted by date, time and call sign of individuals(s). If warranted, the Repeater Trustee(s) may shut a repeater down if infraction committed is warranted. All infractions should be brought to the attention of the Board of Directors for possible further action.

For technical matters, the Repeater Trustee(s) will notify the Technical Vice-President of the issue. The Repeater Trustee(s) reserves the right to aid in the technical maintenance of the repeaters.

The Repeater Trustee(s) will have a budget on which they may freely draw for the maintenance of the Associations repeaters.

This budget will be set by the Board of Directors and or General Membership.
