

EDUCATIONAL STATEMENT

Ember 911, Inc. ("E911") is an Illinois non-profit corporation and a Florida non-profit foreign corporation, established in Florida since March 28, 2016. E911 has been locally established with their current headquarters at 312 S. 2nd St, Leesburg, FL, since 2019. The corporation will be moving their headquarters to the transmitter and studio location, 103 Rosefield Av, Leesburg, Florida with this construction permit.

E911 has been working with working and teaching individuals with Autism since 2008. Pursuant to §73.503(a), E911 proposes to use the station to advance their organization's educational program through outreach and over-the-air public instruction to the general public regarding the awareness of Autism with a focus on reaching students of Beacon College, a special needs college in Leesburg, which has a significant student body within the spectrum. The station will be used to provide a great extracurricular learning opportunity for students that the college does not offer.

Instructional programming will include teaching individuals with Autism on how to better understand their situational surroundings including emergency situations and to improve safer interaction skills with first responders and other individuals they may come into contact with. The station will also utilize music as a part of their instructional program as music is a big part of the lives of many with Autism and to do so in a non-traditional way. E911 is partnering with a local recording studio located in the same building as the proposed radio station so students can record and then have an outlet for their music, helping them improve their technical and communication skills.

E911 claims the Established Community Presence point, pursuant to §73.872(b)(1).

Local Programming – 1 point

E911 pledges to originate at least 8 hours of local programming, pursuant to Commission policies regarding the LPFM point system, pursuant to §73.872(b)(2).

Main Studio – 1 point

E911 pledges to make available an accessible main studio, capable of program origination for a minimum of 20 hours per week. E911 claims the Main Studio point, pursuant to §73.872(b)(3).

Local Programming and Main Studio – 1 point

As both the Local Programming and Main Studio points are being claimed, the additional Local Programming and Main Studio "bonus" point is also claimed, pursuant to §73.872(b)(4).
