

EDUCATIONAL STATEMENT

Reachout was founded on December 29, 2020 with the educational objective of promoting ESL (English as a Second Language), culturally appropriate health literacy, prevention, health and safety training.

Promoting health in immigrant populations is difficult due to cultural, linguistic and socioeconomic barriers.

The radio station will advance our educational program through the on-air teaching of the various ways that we teach in our classes as well as introduce those who are interested in the learning basic English as Second Language, basic health literacy, safety training and more. In addition, we will provide guidance on how to best practice proper English health and safety.

Our programming includes:

ESL and Language Proficiency:

1. **Objective:** Improve English language proficiency to enhance effective communication in healthcare settings and daily life.
 - o **Outcome:** Participants will demonstrate increased ability to express health concerns, understand medical instructions, and engage in basic conversations.

Culturally Appropriate Health Literacy:

2. **Objective:** Develop culturally sensitive health literacy skills to understand and navigate the healthcare system.
 - o **Outcome:** Participants will be able to comprehend health-related information, including medical forms, prescription labels, and preventive care instructions.

Prevention and Health Maintenance:

3. **Objective:** Increase awareness of preventive healthcare measures and promote healthy lifestyle choices.
 - o **Outcome:** Participants will demonstrate knowledge of preventive screenings, vaccinations, and personal health practices for maintaining well-being.

Health & Safety Training:

4. **Objective:** Provide training on health and safety practices in everyday life, both at home and in the community.
 - o **Outcome:** Participants will exhibit an understanding of safety protocols, emergency procedures, and basic first aid.

Immigration Procedure and Updates:

5. **Objective:** Foster understanding of immigration procedures, rights, and updates to navigate legal processes effectively.
 - o **Outcome:** Participants will be informed about their legal rights, responsibilities, and any recent updates in immigration policies.

Basic Laws & Regulations:

7. **Objective:** Provide knowledge of basic laws and regulations governing daily life and interactions in the host country.

- o **Outcome:** Participants will understand key legal concepts, such as rights, responsibilities, and consequences, to navigate daily activities successfully.

Community Engagement:

8. **Objective:** Facilitate community involvement and social integration.

- o **Outcome:** Participants will actively participate in community events, connect with local resources, and build a sense of belonging.

9. **Also:**

1. Providing a platform for local voices: We will provide a platform for local voices to be heard through news, talk shows, and other programs. Our station will be open to community members who want to share their perspectives on local issues, cultural events, and other topics of interest.
2. Building community engagement: Our station will promote community engagement through public service announcements, community calendars, and other programming. We will work with community organizations and leaders to ensure that our programming reflects the needs and interests of the local community.
3. Fostering a sense of community pride: Our station will foster a sense of community pride by showcasing the unique culture, history, and traditions of the local area. We will also provide opportunities for community members to come together and celebrate through live broadcasts and community events.


