

**ATTRIBUTABLE INTERESTS**  
**DIVESTITURE PLEDGE**

A board member for applicant Radio Education Network, Inc. (A Florida nonprofit corporation) (“REN Florida”), Frank Maurizio currently has an attributable interest in Radio Education Network, Inc. (a Nevada nonprofit corporation) (“REN Nevada”), licensee LPFM station KPFV-LP, Pahrump, Nevada (Facility ID No. 191831).

§73.855(a) of the Commission’s Rules prohibits the authorization of an LPFM station, which will result in any party holding an attributable interest in two or more LPFM stations.

To address this issue, REN Nevada proposes to divest itself from KPFV-LP prior to program testing of the instant facility for REN Florida. This divestiture can take place through either assignment or surrender of the KPFV-LP station license.

REN Florida acknowledges that any construction permitted for the instant application will include a condition that will prohibit engaging in program test until either the REN Nevada KPFV-LP license is voluntarily surrendered to the Commission or after the consummation of a granted application to assign the license to a different entity.
