Articles of Incorporation

FAITH BAPTIST CHURCH OF DEFIANCE, OHIO, INC.

(Name of Corporation)

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under Sections 1702.01 et seq., Revised Code of Ohio, do hereby certify:

FIRST. The name of said corporation shall be Faith Baptist Church of Defiance, Ohio, Inc.

SECOND. The place in Ohio where the principal office of the corporation is to be located is City of Defiance, Defiance County.

(City, Village or Township)

THIRD. The purpose or purposes for which said corporation is formed are:

The members of this church shall worship and labor together according to the teachings of the New Testament, as set forth in the articles of faith adopted by this church.

This church shall have the authority to conduct a Baptist church in accordance with the Word of God, the articles of faith, the covenant and the constitution of this church. It shall have the right to own, buy or sell tangible properties, both real and personal, in its own name and through properly elected officers, when authorized by vote of the church.

This church shall be independent and autonomous, not subject to any ecclesiastical control whatsoever from any convention, conference, association, council, group or individual outside of the local church; but it shall have the right to voluntarily affiliate with any association or council of Bible-believing churches separated from the apostasy, and the right to dissociate from any group with which it may have become affiliated.

The government of this church shall be vested in its membership. Voting privileges shall be extended to members in good and regular standing sixteen years of age and over, except that the minimum age shall be twenty-one years for the transaction of all legal matters.

No profit shall ever accrue to the benefit of any individuals from the assets, holdings or other transactions in which this corporation may become involved.

In the event of the dissolution of this corporation, all of its debts shall be fully satisfied. None of its assets or holdings shall be divided among the members, or other individuals, but shall be irrevocably designated by corporate vote, prior to dissolution, to such other non-profit religious corporations as are in agreement with the letter and spirit of the articles of faith adopted by this church, and in conformity with the requirements of the United States Internal Revenue Service Code of 1954 (Section 501 C-3).

FOURTH. The following persons, not less than three, shall serve said corporation as trustees until the first annual meeting or other meeting called to elect trustees.
