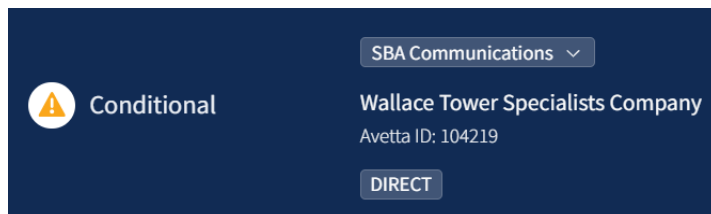

Hi Alyx,

Thank you for submitting supporting documentation and addressing the elevated EMR rating. The Corrective Action / Preventive Action letter (CAPA) was reviewed and accepted. A variance was granted, and WTSC is now on a Conditional Approved status for SBA in Avetta:



The EMR variance is valid until the next annual update. During the annual Update, all suppliers accounts are automatically tasked with new submittals of safety related documentation and metrics for the previous year. I am confident the EMR rating will continue to go downward based on the actions taken and described on the CAPA. If the variance needs to be extended further, we will revisit at the time. Wallace Tower Specialists Company may now submit NTP requests and access SBA sites, after obtaining the approved NTP from our SBA's Tower Network Operation team.

I also noticed that there was a temporary variance placed on our EMR, until April of next year.

I am attaching a corrective action letter to this e-mail on what caused our EMR to be higher than the industry standard, as well as what measures have been implemented and what our intentions are moving forward, in hopes that this variance will be extended indefinitely.

Same problems, different day... Avetta loves to throw poop in the fan.

Avetta... the solution to all tower owners problems... yet always creating more problems.

So they finally did their job and went to “approve” us (The last 3% that I mentioned), and as it turns out... the 3% was them waiting to review our safety manual. Why they waited for 2 months to do it, I’ll never know. Anyway, our “safety manual” Alyx uploaded to them was one that we had created in the past. It is around 25 pages long... Someone at Avetta denied it... he said it wasn’t a “comprehensive” safety manual. Alyx asked what would be considered “comprehensive” and he said most manuals are 150-600 pages long.

The SUPER FRUSTRATING thing is... they had 2 months to figure this out and deny us then. We would be already approved if we could have put this fire out 2 months ago. I would think that they would expedite handling our account after their lack of performance in the past.

So we are now currently speaking to our safety company to get one ordered “off the shelf” I presume. We are going to “put this fire out” very quickly and get this manual... and then I am going to put the heat on them for putting us in this situation.

Aside from him offering to contact our auditor directly (which I have already personally done in the past), he gave me the general e-mail for their Audit Dept., which I am going to inquire with as soon as I am finished with this e-mail. If I find anything out before any of you, I will be sure to let everyone know so we can proceed. I know this is frustrating for you all too, but hopefully the ball is rolling in the right direction now...
