

Consent Decree Compliance

Pursuant to Paragraph 21 of the Consent Decree (“Consent Decree”), dated March 7, 2022, by and between Lowcountry 34 Media, LLC (“Lowcountry”) and the FCC’s Media Bureau (DA 22-232, Acct. No. 202241420002, FRN 0027121466), Lowcountry hereby provides the following information pertinent to this minor modification for W16EE-D, Augusta, Georgia (Facility ID No. 181854) (“W16EE-D”):

1. **Purpose of the Application.** W16EE-D’s Minor Modification Application was originally filed on March 9, 2022 by its previous licensee. Lowcountry became W16EED’s licensee on July 21, 2023. See LMS File Nos. 0000215910 and 0000218416. Following its acquisition of W16EE-D, Lowcountry subsequently filed a minor modification application to relocate the station to a new transmitter site available to Lowcountry which can support permanent operations of the station, which was granted on August 1, 2023. See LMS File No. 0000186170. W16EE-D then went silent on September 27, 2023, to permit Lowcountry to construct the station’s new facilities at its new site. See LMS File No. 0000221511. Pursuant to the instant application, Lowcountry proposes to maximize W16EE-D’s facilities at the newly authorized site – thereby permitting the station to resume operations.
2. **Granted Minor Modification Applications.** W16EE-D has been granted the following minor modification applications during the previous 12 months:

LMS File No. 0000186170 (granted August 1, 2023)
3. **Rural Filing Window.** W16EE-D was originally authorized as part of the 2009 Rural LPTV Filing Window.
4. **Certification.** Attached hereto is a certification, signed under the penalty of perjury by Lowcountry’s Manager, Jeffrey Winemiller, demonstrating that Lowcountry intends to construct and operate a permanent facility for W16EE-D in a manner that is consistent with the Communications Laws (as that term is defined in the Consent Decree).
