ARTICLES OF INCORPORATION

OF

DELTA 2000

A CALIFORNIA PUBLIC BENEFIT CORPORATION

ONE: The name of this corporation is DELTA 2000.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are to assist public, private and community groups in working together to provide needed resources and services for all East Contra Costa residents and to mobilize volunteerism as a means of carrying out those activities which contribute to solving regional problems.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Jeffrey D. Huffaker, 2211 Railroad Avenue, Pittsburg, California.

FOUR: (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propoganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for Delta 2000 for purposes of providing support services to the community, and to non-profit organizations within the community and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.






