

**CHANGES AS A RESULT OF TRANSFER**

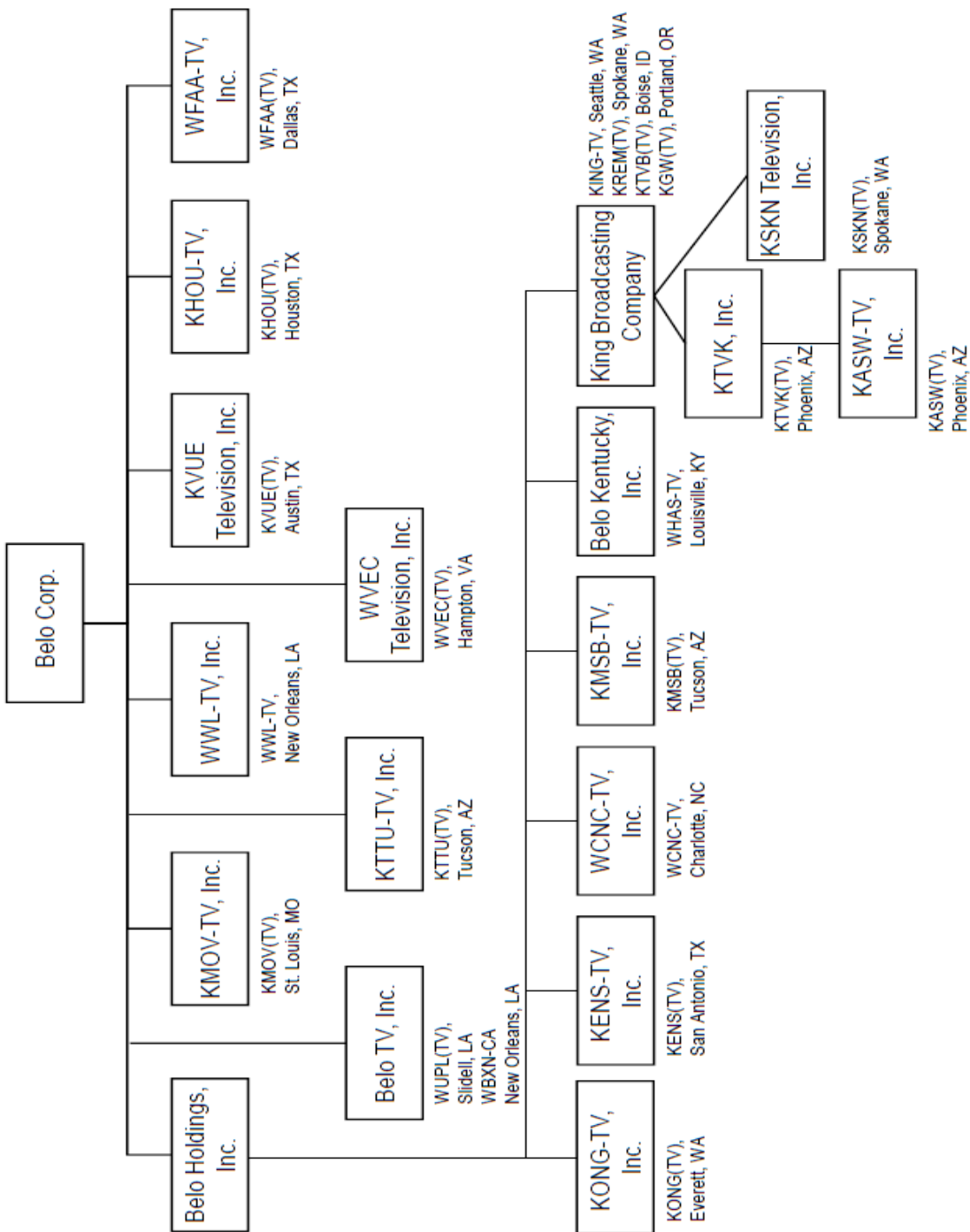
Belo Corp. (“Belo”) is a publicly traded corporation which is the direct or indirect 100 percent shareholder of the licensees of full-power television stations and associated facilities in fifteen Designated Market Areas, as set forth in Exhibit 6. Attached as Appendixes A and B hereto are an organizational diagram for Belo and its subsidiaries and a list of Belo’s officers, directors, and five percent or greater voting shareholders.

As discussed in detail in Exhibit 15A, this application is one of a series of eleven applications on FCC Form 315 seeking Commission consent to a proposed merger whereby Delta Acquisition Corp., a Delaware corporation and wholly-owned subsidiary of Gannett Co., Inc. (“Gannett”), will be merged with and into Belo, with Belo surviving the merger as a wholly-owned subsidiary of Gannett.<sup>1</sup> As a result of the merger, control of the television stations and other facilities licensed to Belo’s several subsidiaries will be transferred from the shareholders of Belo to Gannett, a publicly traded corporation. The stations and other facilities that are the subject of the instant application are identified in response to Section III, Item 2.

Information concerning Gannett and the persons who will hold attributable interests in Gannett following consummation of the merger is set forth in the transferee’s portion of the application.

<sup>1</sup> Simultaneously with the merger, seven of the Belo television stations (KTVK, KASW, KMSB, KTTU, WHAS-TV, KMOV, and KGW) will be assigned to other parties. Applications for consent to such assignments are being filed concurrently herewith. See Exhibit 15.
