EXHIBIT A

At its licensed (and proposed) site, WFMS has shortspaces to WIAU, Channel 240A, Franklin, Indiana; WHIO-FM, Channel 239B, Piqua, Ohio and WVNI, Channel 236A, Nashville, Indiana, as indicated on Exhibit A1.¹ WFMS initially commenced operation in March 1957. Stations WIAU and WHIO-FM commenced operation in December 1961 and November 1960, respectively. As such, the shortages to both of these stations are a result of changes in the Commission's rules since the stations' inception and are considered pre-1964 grandfathered shortspaces, pursuant to §73.213(a).

No actual technical changes are proposed for WFMS, only a community of license change. Therefore, there is no change to the pre-existing shortages to either WIAU or WHIO-FM, and it is believed that this proposal is in compliance with §73.213(a) of the rules with respect to both WIAU and WHIO-FM.

The shortage between WFMS and WVNI was created when the licensee of WVNI decreased the distance between the stations and invoked §73.215 processing, protecting WFMS as a maximum Class B facility. As such, WFMS is considered a fully spaced station, pursuant to

§73.207 of the rules, towards WVNI. As WLI is not proposing any technical changes to the WFMS facilities, the spacing towards WVNI will not be changed, and it is believed that WFMS remains compliant with §73.207 towards WVNI.

Therefore, WFMS remains in compliance with §73.213(a) of the rules towards WIAU and WHIO-FM, and §73.207 towards all other stations.
