**JOINT REQUEST FOR APPROVAL OF SETTLEMENT AGREEMENT  
AND REQUEST FOR GRANT OF APPLICATION**

St. Joseph's Catholic School, Inc. (SJCS) and Community Broadcast Services (CB), by their respective attorneys, hereby respectfully submit their "Joint Request for Approval of Settlement Agreement". Further, SJCS respectfully requests that the Commission grant its application for a construction permit for a new non-commercial educational FM Broadcast Station at Gray Court, South Carolina. In so doing, the following is shown:

1. Attached hereto as Exhibit A is Settlement Agreement by and between SJCS and CB. This agreement

contemplates that, subject to Commission approval of this Joint Request, SJCS would reimburse CB for its expenses reasonably and prudently incurred in the preparation, filing and prosecution of its above-captioned application at Laurens, South Carolina, up to a maximum amount of \$9,500.00, in exchange for the dismissal of the CB application at Laurens. The agreement contains the representations required by Section 73.3525 of the Commission's Rules that the CB application was not filed for the purpose of delay and that no consideration, direct or indirect, has been paid or promised to CB for its decision to dismiss its application other than that which is disclosed in the Settlement Agreement.

2. In their settlement agreement, both SJCS and CB declare under penalty of perjury that: (1) neither application was filed for the purpose of reaching or carrying out a settlement agreement; (2) their settlement agreement will serve the public interest by eliminating the need for expensive and protracted hearing proceedings before the FCC and enabling new service to the public to be implemented at the earliest possible date; and (3) no consideration, direct or indirect, has been paid or promised to be paid by SJCS or any other party to CB or its

principals or affiliates to obtain the dismissal of the CB application at Laurens, South Carolina.

3. This settlement agreement is in the public interest because it will conserve scarce FCC adjudicatory resources, and it will also avoid the confusing scenario of two different licensees operating separate FM stations on the same frequency in the same area. The SJCS application has been accepted for filing and is available for an immediate grant.

**WHEREFORE**, St. Joseph's Catholic School, Inc. and Community Broadcast Services urge that (1) their Joint Request for Approval of Settlement Agreement **BE GRANTED**; (2) the application of Community Broadcast Services for a new NCE FM Station at Laurens, South Carolina (File No. BNPED-20071018AMP) **BE DISMISSED**; and (3) the application of St. Joseph's Catholic School, Inc. for a new NCE FM Station on Channel 213 at Gray Court, South Carolina (File No. BNPED-20071022BHF) **BE GRANTED**.


