EXEMPT ACKNOWLEDGEMENT LETTER

Part II

Question 1

Centro Internacional de Oracion (the "Corporation") was formed on 11/7/2007 in the State of California. The Articles of Incorporation of the Corporation are attached hereto as Exhibit A.

Question 5

The Bylaws of the Corporation are attached hereto as Exhibit B.

Part IV

The Corporation is organized and will operate exclusively for religious purposes. The activities of the Corporation will include the following:

1. As permitted under the Internal Revenue Code of 1986 (the "Code"), the Corporation operates an Evangelical Christian television station as an effective means of spreading the Gospel to all cultures and peoples within the broadcast zone. The Corporation performs and records two services for broadcasting every week. The Corporation provides coverage of Spanish and English language religious and spiritual programs twenty-four hours a day, and seven days per week, without advertising. The television station ("Channel 6") can also be heard over the radio. Viewers and listeners make charitable contributions to the Corporation solely for purposes of furthering the religious purposes of the Corporation.

2. In addition, the Corporation provides religious education and instruction, and renders Christian services through material, spiritual, educational, and emotional means to those in need, and to associates of churches and organizations with similar purposes.

3. The Corporation also makes grants to various organizations which are organized and operated for religious purposes and which are exempt from Federal income taxation under Section 501(c)(3) of the Code.

Part V

Question 2a

Rafael Porras and Obidia Porras are husband and wife. Byron Castellanos and Lisa Castellanos are husband and wife. No other family or business relationships exist between the officers and directors.

Question 3a

Rafael Porras – Chief Executive Officer/President and Director

Qualifications: Rafael Porras has years of experience as both an Engineer and a Pastor. Rafael currently spends, and will continue to spend, approximately 8-12 hours per week working on behalf of the Corporation.

Duties: The President will perform the following duties: (i) supervise, direct and control the business affairs of the Corporation and the activities of the Officers of the Corporation, subject to the oversight of the Board of Directors; (ii) preside at all meetings of the Board of Directors; and (iii) such other powers and duties as may be prescribed by the Board of Directors and the Bylaws. The Board of Directors will, subject to the provisions of the California Nonprofit Corporation Law, manage the business and affairs of the Corporation. The Board of Directors will also have all the duties and powers conferred to them under the Bylaws of the Corporation.

Obidia Porras – Vice President and Director

Qualifications: Obidia Porras has years of experience as a Pastor. Obidia currently spends, and will continue to spend, approximately 8-12 hours per week working on behalf of the Corporation.

Duties: The Vice President will act in all corporate matters in the absence or disability of the Chief Executive Officer/President. Her duties as a member of the Board of Directors' duties are set forth above.

Byron Castellanos – Chief Financial Officer/Treasurer and Director

Qualifications: Byron Castellanos is a Youth Pastor. Byron currently spends, and will continue to spend, approximately 8-12 hours per week working on behalf of the Corporation.

Duties: The Chief Financial Officer/Treasurer will perform the following duties: (i) keep and maintain the financial books and records of accounts of the Corporation; (ii) prepare annual financial statements, as required; (iii) handle all deposits and disbursements made on behalf of

the Corporation; and (iv) perform such other duties as prescribed by the Board of Directors or the Bylaws of the Corporation. The Board of Directors' duties are set forth above.

Lisa Castellanos – Secretary and Director

Qualifications: Lisa Castellanos is a Youth Pastor. Lisa currently spends, and will continue to spend, approximately 8-12 hours per week working on behalf of the Corporation.

Duties: The Secretary will perform the following duties: (i) certify and keep the corporate books and records of the Corporation; (ii) give notice of, attend and record minutes of all of the proceedings of the Board of Directors and of any corporate committees; maintain the seal of the Corporation, if any be adopted, in safe custody; and (iv) perform such other duties as prescribed by the Board of Directors or the Bylaws of the Corporation. The Board of Directors' duties are set forth above.

Question 5a

The Corporation has adopted, by a Unanimous Written Consent by the Board of Directors in Lieu of an Organizational Meeting ("Unanimous Written Consent"), a conflict of interest policy which is substantially in accordance with the sample policy provided with the instructions of Form 1023. A copy of the Unanimous Written Consent along with the Corporation's conflict of interest policy is attached hereto as Exhibit C.

Question 8a

The Corporation does not have any leases, contractors, loans or other formal agreements with its officers nor with its directors. However, Obidia Porras owns the television station used by the Corporation for its religious broadcasts, and donates the use of the station to the Corporation without compensation of any kind. No payments for the use of the station are made by the Corporation to Ms. Porras or any other directors and/or officers of the Corporation.

Part VI

Questions 1a, 1b

The Corporation creates and provides services in the form of religious television (and radio) programming to individuals and organizations, as described under Part IV, above.

Part VIII

Questions 4a

The only fundraising activity currently engaged in by the Corporation is the solicitation of charitable contributions from its viewers and listeners. At various times throughout the broadcast, the Corporation requests that viewers and listeners send donations to the Corporation

for the purposes of furthering the Corporation's religious purposes. In the future, the Corporation may raise funds through mail, phone, or personal solicitations.

Question 11

Donations of real property will be accepted if they can be converted to cash with relative ease for use of the Corporation's religious purposes.

Questions 13a-g

How Donations Further the Corporation's Religious Purposes: Currently, the Corporation makes monthly donations to Alma Vision Hispanic Network, Inc. ("Alma Vision"), a church which is exempt from federal income tax under Section 501(c)(3) of the Code, and such donations further the religious purposes of the Corporation in that Alma Vision provides worshippers with an actual place of worship and the opportunity to attend services.

Identity and Relationship of Organizations: Currently, Alma Vision is the only organization to which the Corporation makes donations, but there is no formal relationship between the two organizations. The Corporation may expand the number of organizations, churches, and/or charities to which it makes donations, but at this time no additional organizations are receiving support from the Corporation. Any additional organizations to which the Corporation might make donations will include only those which would use the donations to further the religious purposes of the Corporation.

Record Keeping: For donations made to Alma Vision and any other organizations, the Corporation retains (and will continue to retain) all paperwork necessary to ensure that such charitable grants are used for religious or other charitable purposes. In addition, the Corporation will require Alma Vision (and any other charitable and/or religious organization or church) to provide the Corporation with annual reports that demonstrate that the grant funds were used for charitable and/or religious purposes.

Part IX

Note: Although the Corporation was formed on November 7, 2007, there was no financial activity for the first short year of its existence, other than the receipt of a small donation of cash as indicated on the Balance Sheet. For this reason, no revenue and expenses were prepared for 2007.

A. Statement of Revenue and Expenses

Line 1: The number in Column 1 (2008) indicates the approximate amount of contributions the Corporation expects to have received from viewers by the end of the 2008 calendar year, based upon current receipts. The numbers in Columns 2 and 3 (2009 and 2010) are projections of the expected support the Corporation expects to raise in the form of gifts, grants, and contributions from viewers and listeners.

Line 15: The numbers on Line 15 represent projected charitable and/or religious grants made to other organizations.
