Dear Ms. Dortch:

Petracom of Holbrook, LLC("Petracom"), by its counsel, hereby requests extension of the Special Temporary Authority ("STA") to operate KZUA, Holbrook, AZ (fac id 47886) ("Station") with reduced transmitter power as set forth in BSTA-20210830AAD.

This STA is necessary to continue service to the public until equipment can be replaced. The licensee has obtained pricing for equipment and when the total is known, financing can be obtained. The licensee is hopeful this can be accomplished in time to install equipment this coming summer.

For the foregoing reasons, Petracom of Holbrook, LLC respectfully requests an extension of the STA to operate the station with reduced facilities pending repairs. Petracom of Holbrook, LLC will inform the Commission when the Station is able to resume operating pursuant to the terms of its license. **Confirmation of filing fee payment is attached to this letter.**
