

Except for the operating agreement of Crestview, L.L.C., each agreement includes provisions that fully comply with the Commission’s restrictions regarding insulation of passive investors.

In addition, the ownership interests, both insulated and non-insulated, in the chain of Crestview’s ownership structure have been assessed to confirm that none of those ownership interests has any bearing on the proposed assignee’s certification in this application of compliance with the alien ownership restrictions set forth in Section 310(b) of the Communications Act of 1934, as amended.


