

**PARTIES TO THE APPLICATION**

This application is being filed to request Commission consent to the voluntary transfer of control of Aries Telecommunication Corporation (“Aries”), licensee of television broadcast station WGBA(TV), Green Bay, Wisconsin, and Class A television station W22BW, Sturgeon Bay, Wisconsin, and permittee of low power television station W31BK, Menominee, Michigan, from the Estate of Donald Eugene Clark, which holds a controlling interest in Aries, to The Donald E. Clark Residuary Estate Trust.

Aries is wholly owned by DP&K, Inc. (“DP&K”). As the Commission is aware, at the death of Donald E. Clark, DP&K’s president, director, and 75% voting shareholder (3% total asset holder), control of the company passed to his estate.<sup>1</sup> Deborah Ann Clutter is the current Executrix of the Estate. The purpose of this application is to seek Commission consent to transfer of control of Aries from the Estate to The Donald E. Clark Residuary Estate Trust. Ms. Clutter is the sole trustee.
