

## **EXHIBIT 11**

Amigo Radio, Ltd. (formerly identified as Amigo Broadcasting, Ltd.)<sup>1/</sup> is a Limited Partnership consisting of Amigo GP, LLC (the General Partner) – 1% ownership interest and Amigo Broadcasting, LP (the Limited Partner) – 99% ownership interest. The officers of Amigo GP, LLC are James L. Anderson, President and Stephen D. King, Vice President.

The Sole Member of Amigo GP, LLC (the General Partner) is Amigo Broadcasting, LP. Amigo Broadcasting, LP is a Limited Partnership comprising Rodriguez Operating, Inc. (the General Partner) – 0.1% ownership interest of Amigo Broadcasting, LP and four Limited Partners – Gammon Broadcasting, Inc. (2.745% ownership interest); Brooks Broadcasting, Inc. (9.020% ownership interest); RFT Broadcasting, Inc. (67.660% ownership interest) and New World Broadcasting, Inc. (20.475% ownership interest).
