PETITION FOR RULEMAKING

SSR Communications, Inc. ("Petitioner") hereby submits this mutually-exclusive hybrid application Petition for Rulemaking to the Commission to: 1) reallocate Petitioner's Auction Number 94 winning bid long-form application (BNPH-20130624AAQ) on FM Channel 288A from Haynesville, Louisiana to Heflin, Louisiana as that community's *first* local FM broadcast service, and 2) allocate FM Channel 286A at Haynesville, Louisiana as a "back fill" allocation for that community (though no local service presently exists in Haynesville). The proposed changes represent a mutually-exclusive amendment to the Commission's Table of Allotments, as FM Channel 286A may not be allocated at Haynesville unless FM Channel 288A is reassigned, as follows:

1 - The allocation on FM Channel 288A at Haynesville was recently won by Petitioner during the Commission's FM Broadcast Auction Number 94 (MM-FM905-A). Petitioner has submitted it long-form application (BNPH-20130624AAQ) for this new facility, proposing the reallocation of this channel from Haynesville to Heflin, Louisiana. The proposed FM Channel 286A allocation would then provide "back fill" service to Haynesville for a future spectrum auction, allowing FM Channel 288A to be reallocated to Heflin. As such, Petitioner will apply for FM Channel 286A at Haynesville in a future spectrum auction, and if won, will build out the station promptly.

This makeup of allocations would represent a *preferential arrangement of the FM Table of Allotments*. Even though Haynesville is not currently being served by a local FM facility, potential future service to that community will not be deprived via the proposed FM Channel 286A allotment. Additionally, the reallocation of FM Channel 288A from Haynesville to Heflin will provide *first local service* to that community.

FIRST LOCAL SERVICE TO HEFLIN, LOUISIANA

The community of Heflin is located in Webster, Parish, Louisiana, and is home to 244 residents, according to the 2010 United States Census. Heflin is home to its own municipal government, United States Post Office and Zip Code (71039), school (Heflin Elementary School), fire department, local library, numerous churches, and many other businesses. Heflin is an incorporated community (generally sufficient for the Commission's allotment purposes), independent of any neighboring communities, and is clearly deserving of its own FM allocation.

FUTURE SERVICE TO HAYNESVILLE, LOUISIANA

The contemplated changes herein would not deprive Haynesville of existing or potential / future local FM radio service. Through the mutually-exclusive rearrangement of allocations proposed above, potential / future service to Haynesville would be preserved with the intended FM Channel 286A allocation, with reference allocation coordinates *identical* to those of the current FM Channel 288A allotment. Currently, Haynesville has no licensed local broadcast facilities, so Haynesville will not be deprived of any operating local broadcast service, thus allowing the reallocation of FM Channel

288A from Haynesville to Heflin. Additionally, Petitioner has not promised service on FM Channel 288A to the residents or businesses within the community of Haynesville at any point in the auction process or this proceeding.

CONCLUSION

Concurrent with this Petition, Petitioner has filed a FCC Form 301 Construction Permit application to construct a new FM facility at Haynesville, Louisiana on FM Channel 286A, as well as a pending FCC Form 301 Long-Form Construction Permit application for its Auction Number 94 facility / permit MM-FM905-A, BNPH-20130624AAQ. In the event that the Commission grant's Petitioner's requests herein, Petitioner asserts that it will participate in any future Commission auction to secure a broadcast license for said facility in Haynesville, as well as construct its proposed facility in Heflin promptly.



The FCC f(50,50) 70 dBu contour is shown above, and clearly encompasses 100% of the community of Haynesville, Louisiana.


