This Technical Statement was prepared on behalf of Glory Communications, Inc., (“Glory”), licensee of WEA, 1130 kHz, Camden, South Carolina. Glory has an application pending (BP-20070119AAM) to relocate WEA and change its city of license from Camden, South Carolina to Springdale, South Carolina. This instant amendment provides further information regarding the gain and loss areas and the services provided to the respective areas, the proposed signal coverage in the Columbia Urbanized Area with the percentage of the population in the Urbanized Area that will be covered by the outstanding application, and shows the distance from the community reference point in Springdale to the community reference point in Columbia.¹

Attached as Exhibit # 7A is a map showing the respective 2.0 mV/m gain and loss areas as proposed in BP-20070119AAM. There will be a loss of 2.0 mV/m service to 54,579 persons with a gain of 2.0 mV/m service to 333,936 persons, an increase of 279,357 persons, a 512% increase.² Attached as Exhibit #7B is a map showing the respective 0.5 mV/m gain and loss

areas as proposed in BP-20070119AAM. There will be a loss of 0.5 mV/m service to 197,129 persons with a gain of 0.5 mV/m service to 368,580 Persons, an increase of 171,451 persons or an 87% increase.³ Exhibit #7C is a map demonstrating there are more than five aural broadcast services remaining in the WEAFF 0.5 mV/m protected service loss area after the relocation of WEAFF, with a tabulation of the stations as Exhibit #7C1. Exhibit #7D is a map demonstrating there are more than five aural services in the WEAFF protected service gain area not considering the relocated WEAFF, with a tabulation of the stations included as Exhibit #7D1. As such, the gain and loss areas are adequately served.

Exhibit #7E shows the proposed WEAFF city grade contour penetration into the Columbia, South Carolina Urbanized Area. The Urbanized Area population served by the proposed WEAFF facility is 118,675 persons, representing 45% of the total population within the Columbia Urbanized Area of 419,251 persons. Further, the proposed facility will provide service to 259.3 square kilometers of the Columbia Urbanized Area. This equals only 36.6% of the area; the total area is 707.6 square kilometers.

The reference coordinates of Springdale and Columbia, South Carolina were extracted from the FCC Audio Division, Atlas, Community Reference Query. Exhibit #7F is the computation of the distance between Springdale and Columbia, South Carolina using those reference coordinates, resulting in a distance of 8.24 kilometers (5.12 miles) between the communities.
