

Narrative Description of Attributable Ownership Interests

Wilks License Company-Lubbock LLC is a Delaware limited liability company. Wilks License Company-Lubbock LLC is a wholly-owned subsidiary of Wilks Broadcast-Lubbock LLC.

Wilks Broadcast Group LLC is a Delaware limited liability company. Wilks Broadcast Group LLC is a wholly-owned subsidiary of Wilks Broadcast Group Holdings LLC.

Wilks Broadcast Group Holdings LLC is a Delaware limited liability company. Managing LLC member Wicks Radio Group LLC has a 90% equity interest and 100% voting interest. LLC member Wilks Broadcast Partners, LLC has a 10% equity interest and 0% voting interest. LLC member Wilks Broadcast Manager LLC has a 0% voting interest and could have up to a 3% equity interest and a further “carried” equity interest which could under certain circumstances be up to 25% (subject to possible forfeiture and performance criteria). Its equity interest would proportionately reduce the equity interests of the other members (after the return of invested capital plus a preferred return thereon).

Wilks Broadcast Manager LLC is a Delaware limited liability company. Managing LLC member Wilks Radio Group LLC has a nominal equity interest and a 100% voting interest. LLC member Jeffrey Wilks has a 100% equity interest and a 0% voting interest, but his equity interest is subject to reduction to the extent equity interests in Wilks Broadcast Manager LLC are granted to other executives. It is anticipated that Marc Berman would acquire an equity interest in Wilks Broadcast Manager LLC corresponding to a capital contribution of up to \$300,000 and a percentage of profits and losses which could correspond in certain circumstances to up to approximately 19.78% (subject to vesting and possible forfeiture and to performance criteria) of the total equity interests in Wilks Broadcast Manager LLC plus a percentage of profits and losses corresponding to a portion of the total equity interests of all investor LLC members of Wilks Broadcast Group Holdings LLC based on the percentage which Mr. Berman’s capital contribution represents of the total invested capital in Wilks Broadcast Group Holdings LLC (expected to be less than 3% of such total invested capital). Mr. Berman would have a 0% voting interest in Wilks Broadcast Manager LLC. It is also anticipated that Jody Rosen would acquire an equity interest in Wilks Broadcast Manager LLC corresponding to a \$1,000 capital contribution and a percentage of profits and losses attributable to Wilks Broadcast-Lubbock LLC which could correspond in certain circumstances to up to 9% (subject to vesting and possible forfeiture and to performance criteria) of the total equity interests in Wilks Broadcast Manager LLC (net of and after giving effect to equity interests corresponding to invested capital as described above).

Wilks Broadcast Partners, LLC is a Delaware limited liability company. Manager and LLC member Jeffrey Wilks has a 60% equity interest and a 60% voting interest. LLC member Donald Wilks has a 15% equity interest and a 15% voting interest. LLC member, Mitchell Wilks Irrevocable Trust u/d/t dated 12/24/87 (for which Jerome E. Caplan and Patricia Wilks are

Trustees), has a 10% equity interest and a 10% voting interest. LLC member, Robin Wilks Irrevocable Trust u/d/t dated 12/24/87 (for which Jerome E. Caplan and Patricia Wilks are Trustees), has 10% equity interest and a 10% voting interest. LLC member Todd Asarah has a 1.5% equity interest and a 1.5% voting interest. LLC member Todd Parmacek has a 2.5% equity interest and a 2.5% voting interest. LLC member Richard H. Doub has a 1.0% equity interest and a 1.0% voting interest. Other members of or trusts for the family of Jeffrey Wilks could acquire equity interests which would proportionately reduce the equity interests of the original LLC members.
