ASSET PURCHASE AGREEMENT

R3

THIS AGREEMENT (“Agreement”), made this 7th day of February, 2018, by and between Radio Center of Jackson, Inc. (hereinafter referred to as Seller), and Pine City Radio, LLC, an Alabama Limited Liability Company, (hereinafter referred to as Buyer).

WITNESSETH:

WHEREAS, Seller is the licensee and owner of AM station WRJX, Jackson, Alabama (FCC Facility ID No. 8604), FM station WHOD, Jackson, Alabama (FCC Facility ID No. 8605) and FM station WBMH, Grove Hill, Alabama (FCC Facility ID No. 8607) (“Stations”); and

WHEREAS, Seller has applied (FCC Application No. BNPFT-20171219ABN) for a construction permit for a new FM Translator for use with WRJX (FCC Facility ID No. 200030). (“Translator”); and

WHEREAS, Seller desires to convey and Buyer desires to purchase all of the licenses, assets, equipment and call letters used or intended for use in the construction and operation of the Stations; and

WHEREAS, Seller and Buyer will not be able to consummate this Agreement without the prior approval of the United States Bankruptcy Court, Southern District of Alabama and Federal Communications Commission (“FCC”) for said purchase and assignment; and

WHEREAS, the Stations are silent and the parties intend to enter into a local marketing agreement (“LMA”) in order to restore operations of the Stations as quickly as possible.

NOW THEREFORE, in consideration of the mutual promises, covenants and conditions contained herein the parties, intending to be legally bound, mutually agree as follows:

1. **ASSETS SOLD AND PURCHASED** – Subject to the terms and conditions of this Agreement, Seller agrees to sell, convey, transfer and assign to Buyer, and Buyer agrees to buy, receive, and assume all of the real and personal property, assets, licenses, equipment and call letters used and intended to be used in the operation of the Stations. Said assets are to be delivered to Buyer from Seller at the time of closing and in compliance with all generally accepted standards and FCC requirements, free and clear of the security interest of Asset Capital, Inc., but otherwise in “as is” condition and without other warranty, express or implied. The Translator cannot be conveyed until the FCC issues a construction permit to Seller. Seller does not warrant that the FCC will grant the application but, in the event the

FCC grants the application for the Translator construction permit, Seller will convey its interest in the Translator upon filing a subsequent application for consent to assignment of the Translator construction permit, so long as Buyer bears all costs relative to such application and subsequent conveyance. Attached hereto is Exhibit A itemizing a list of equipment to be conveyed as part of this purchase agreement. The Purchaser has inspected all Radio Center of Jackson, Inc. facilities and has confirmed and is satisfied that the list of equipment as itemized on Exhibit A is present at the station facilities. The Trustee makes no representations or warranties regarding the existence, nonexistence or condition of the equipment as itemized on Exhibit A.

2. **PURCHASE PRICE** – The total consideration to be paid by the Buyer to the Seller for the property, licenses and assets to be acquired by Buyer shall be TWO-HUNDRED THOUSAND AND NO/100 DOLLARS (\$200,000.00) to be paid as follows:
 - (A) An earnest money deposit of \$20,000.00 (TWENTY THOUSAND AND NO/100 DOLLARS) shall be paid by Buyer to the Bankruptcy Trustee in cash upon execution of this Agreement, by deposit of that sum into the Bankruptcy Estate Account either by wire or certified funds. In the event the FCC or US Bankruptcy Court, Southern District of Alabama, fails to approve the sale of the stations as expressed in this Agreement, the balance of the earnest money funds less any expenses and/or bank fees will be returned to the Buyer.
 - (B) At closing Buyer will pay the balance of the purchase price by wire transfer or certified funds in the amount of 180,000.00 (ONE HUNDRED EIGHTY THOUSAND AND NO/100 DOLLARS.)
 - (C) Buyer will have ownership of all outstanding accounts receivable.
 - (D) Buyer agrees to pay the FCC filing fee for the filing of the appropriate Assignment Application.
 - (E) Seller agrees to give public notice of the Assignment Application, as required by the FCC's rules, and Buyer will pay any fees incident to such notice.

3. **CONDITIONS PRECEDENT** – This entire Agreement is subject to and contingent upon Bankruptcy Court approval from the United States Bankruptcy Court, Southern District of Alabama, approval of the FCC to the terms of this Agreement and the Assignment of the permits of Stations. The parties shall cooperate in the prompt execution of filing of an Assignment Application on the proper FCC form and all other instruments necessary in order to obtain the consent of the FCC to the Assignment contemplated herein. Said application shall be filed within (5) days following the execution of this Agreement. For

purposes of this Agreement, “Final Approval” shall be defined as an Order by the United States Bankruptcy Court and the FCC approving the sale and granting the Assignment Application filed by the parties hereto, which Order is no longer subject to appeal or reconsideration by the parties or by third persons, or subject to review by the Commission on its own motion.

4. **CLOSING** – Closing shall take place following an order approving the sale executed by the United States Bankruptcy Court, Southern District of Alabama, and receipt of Final Approval.

5. **SELLER’S REPRESENTATIONS AND WARRANTIES** – Seller represents and warrants to Buyer as follows:
 - (B) That Seller conveys all assets of the Stations free and clear of the security interest and/or mortgage of Capital Assets, Inc.
 - (C) That Seller is in compliance with all applicable laws rules and regulations of all federal, state, and local authorities having jurisdiction over Seller and the Stations, including the FCC.

6. **BUYER’S REPRESENTATIONS AND WARRANTIES** – Buyer represents and warrants to the Seller as follows:
 - (A) That Buyer will, at closing, be legally and financially qualified and able to undertake performance of the obligations set forth in Agreement and to become an FCC licensee of the Stations; and
 - (B) Except for the consent of the FCC and the United States Bankruptcy Court, Southern District of Alabama, no further consent of any kind is required, and Buyer knows of no reason why final approval would not be granted by the FCC.
 - (C) **RISK OF LOSS**. During the period of the LMA operation, the Buyer shall purchase insurance on the facilities and equipment, the proceeds from any claims shall be paid to the Bankruptcy Estate upon consideration by the US Bankruptcy Court insurance proceeds will be distributed by the Court.

7. **REMEDIES** - The parties agree that the assets and property to be conveyed under this Agreement are unique and cannot be readily purchased and sold in the open market. Should the Buyer willfully and wrongfully breach this Agreement or fail or refuse to settle in accordance with the terms of this Agreement, the Seller’s remedy shall be liquidated damages for such breach in the amount of the earnest money deposit in escrow in the Bankruptcy Estate Account.

8. **PERFORMANCE AT CLOSING** –

- 8.1 Seller shall deliver to Buyer or Buyer's duly authorized agent, at closing, A Bill of Sale and Quit Claim Deed, transferring to Buyer title to all real property, tangible and intangible personal property and licenses to be conveyed under the terms of this Agreement, free and clear of the security interest Capital Assets, Inc. The parties recognize and agree that all property is sold "as is/where-is", and Seller makes no warranties, express or implied, as to the condition or operability of the property. Buyer warrants he has investigated status of all property to be conveyed and by Closing the purchase of the Stations warrants that it is satisfied with the status of the property conveyed.
- 8.2 Seller shall deliver to Buyer all licenses, permits and authorizations issued by the FCC for operation of or issued in connection with the operation of the radio stations.
- 8.3 Buyer shall deliver to Seller the balance of the purchase price, as set forth in paragraph 2(b) and 2(c) hereof; subject to any adjustments provided for by this Agreement.

9. **PRORATION OF EXPENSES** – Seller shall be responsible for all expenses accrued or incurred prior to, or arising from the Stations' operations prior to the execution of the LMA Effective Date, including but not limited to property taxes and utility bills, and Buyer shall be responsible for all such expenses thereafter. Buyer shall be entitled to all income for services rendered or to be provided by the Stations on and after the closing date.

10. **MISCELLANEOUS** – The United States Bankruptcy Court, Southern District of Alabama and any applicable federal laws and regulation of FCC matters shall govern in all matters affecting this Agreement and any disputes which may arise hereunder. The headings contained in this Agreement as for reference purposed only and shall not affect in any way the meaning or interpretation of this Agreement. This Agreement and the attachments hereto contain the entire Agreement of the parties with respect to the transactions contemplated and supersede all prior negotiations between the parties concerning the subject matter contained herein. No change, modification or waiver of any provision hereof will be valid unless in writing and signed by the parties hereto. No delay or failure on the part of either party in exercising any rights hereunder, and no partial or single exercise thereof, will constitute a waiver of such rights or of any other rights hereunder. The provisions hereof shall service the closing hereunder in accordance with the terms of this Agreement and shall be binding upon and inure to the benefit of all of the parties hereto, their heirs, executors, administrators, legal representatives, successors and assigns. This Agreement may be executed in counterparts. Each of such counterparts shall for all purposes be deemed an original; all of such counterparts together shall constitute complete execution of this Agreement. This Agreement shall be binding upon, and shall inure to the benefit of, the parties to this Agreement, their heirs, successors and assigns.

11. Until the Closing, control of the Stations shall remain vested in Seller and Buyers shall take no action to control the Stations except as permitted under the LMA.

12. This contract may not be assigned by Buyer without the Seller's written consent, except to a corporation of which Buyer is sole stockholder.
