To create, manage, and promote the use of local access television in the Bismarck-Mandan area, and to conduct all activities whatsoever in its management and promotion, including but not limited to the hiring of employees and personnel to run the station; the obtaining of the necessary equipment and studio facilities to conduct the affairs of a cable access television station; the promotion of the station in the affected communities; solicitation of support, both financial and in-kind, to aid in the operation of the station; and any other activity allowed under the laws of the United States and the State of North Dakota in the conduct of non-profit, communications corporations.

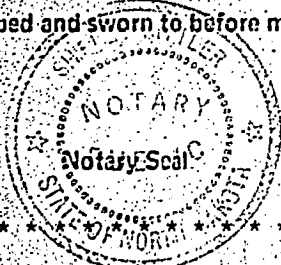

AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF CAT, INC.

ARTICLE 1. The name of said Corporation shall be: CAT, Inc.

ARTICLE 2. The period of its duration is: perpetual

ARTICLE 3. The purposes for which the Corporation is organized are:

To provide literary, educational, and community interest programs to the citizens of Bismarck, North Dakota, via a cable channel; to provide citizens, interest groups, and subcommittees of the City of Bismarck the opportunity to present information and share their resources with the general public via the cable channel, at little, if any cost; to provide training courses, production equipment, limited production services, engineering support, promotion services by the use of cable to promote upcoming events and programs, and channel and schedule times, to facilitate the above two purposes; to solicit support, both financial and in kind, to fulfill the above stated purposes.

ARTICLE 4. This Corporation is not organized for profit and shall have no capital stock.

ARTICLE 5. Provisions for the regulation of the internal affairs of the Corporation, including provisions for distribution of assets on dissolution or final liquidation are:

As stated in the Bylaws, and as follows:

- a. No part of the net earnings, gains or assets of the Corporation shall inure to the benefit of or be distributable to its directors, officers, other private individuals, or organizations organized and operated for a profit (except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as hereinabove stated). No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall be empowered to make the election authorized under Section 501(h) of the Internal Revenue Code of 1986. The Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision

herein, the Corporation shall not carry on any activities not permitted to be carried on -

- (a) By an organization exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986 as an organization described in Section 501(c)(3) of such Code;
- (b) By an organization described in Sections 509(a)(1), (2) or (3) of the Internal Revenue Code of 1986 (as the case may be), and/or;
- (c) By an organization, contributions to which are deductible under Sections 170(c)(2), 2055(a)(2), or 2522(a)(2) of the Internal Revenue Code of 1986.

- b. The Corporation is organized and operated exclusively for charitable and social welfare purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986.

In the event of dissolution or final liquidation of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the lawful debts and liabilities of the Corporation, distribute all the assets of the Corporation to one or more of the following categories of recipients as the Board of Directors of the Corporation shall determine:

- (a) A non-profit organization or organization which may have been created to succeed the Corporation, as long as such organization or each of such organizations shall then qualify as a governmental unit under Section 170(c) of the Internal Revenue Code of 1986 or as an organization exempt from federal income taxation under Section 501(a) of such code as an organization described in Section 501(c)(3) of such Code; and/or
- (b) A non-profit organization or organizations having similar aims and objects as the Corporation and which may be selected as an appropriate recipient of such assets, as long as such organization or each of such organizations shall then qualify as a governmental unit under Section 170(c) of the Internal Revenue Code of 1986 or as an organization exempt from federal income taxation under Section 501(a) of such code as an organization described in Section 501(c)(3) of such code.

References herein to sections of the Internal Revenue Code of 1986 are to provisions of such code as those provisions are now enacted or to corresponding provisions of any future United States revenue law.

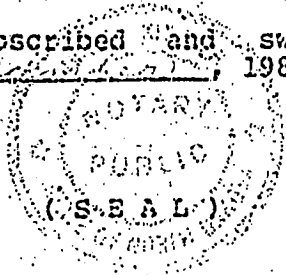
