Agreements for Sale of Station

This application seeks consent to the assignment of the FCC licenses of WQXR-FM, New York, NY (Facility ID No. 29022) from The New York Times Radio, LLC ("Assignor") to WADO-AM License Corp. ("Assignee"). The transaction described in this application is embodied in the following documents:

1. An Asset Exchange Agreement between Assignor and Assignee dated July 14, 2009 (the "Exchange Agreement");
2. Exhibit A to the Exchange Agreement, which is an Assignment and Assumption of Certain Rights and Obligations under the Exchange Agreement between Assignor and WNYC Radio (the "Assignment and Assumption") to be signed on the day of closing, and
3. An Asset Purchase Agreement between Assignor and WNYC Radio dated July 14, 2009 (the "Purchase Agreement").

Copies of each of these documents are attached hereto and are being placed in the public inspection file of WQXR-FM.

Pursuant to the terms of the Exchange Agreement, Assignor will assign to Assignee certain assets held for use in the operation of WQXR-FM, including the FCC licenses of the station. In return, Assignee will assign to WNYC Radio, as designee of Assignor pursuant to the Purchase Agreement and the Assignment and Assumption, certain assets held by Assignee in the operation of WCAA(FM), Newark, NJ (Facility ID No. 46978), including the FCC licenses of that station. A separate application is being filed requesting Commission consent to the assignment of the licenses of WCAA(FM) from Assignee to WNYC Radio. Consummation of the assignment of the licenses of WQXR-FM to Assignee and the assignment of the licenses of WCAA(FM) to WNYC Radio are mutually contingent, and the parties therefore request that the Commission process these applications together.

The disclosure schedules to the Asset Exchange Agreement and the Asset Purchase Agreement have been omitted from this Exhibit 4 and from the public inspection file copy because they contain material that either is proprietary, not germane to the Commission's evaluation of this application, or already in the Commission's possession. A list of the omitted schedules is provided below. If necessary, upon the Commission's request, copies of the omitted documents will be promptly provided. Pursuant to the Commission's decision in *LUJ, Inc.*, 17 FCC Rcd 16980 (2002), and the Media Bureau's Public Notice, DA 02-2049 (rel. Aug. 22, 2002), Section II, Question 3 of this application has been answered in the negative.
