Other Authorizations

Superior Broadcasting of Denver, LLC (“Superior Denver”)

Bruce Buzil, Andrew Barrett, and Robert Neiman are members of Superior Denver. Christopher Devine is a manager and director of Superior Denver. Bruce Buzil holds 34% of the common units in Superior Denver. The common (voting) units represent Founders’ Equity which entitles the holder to receive certain payments if Superior Denver meets certain performance standards and otherwise represents a limited equity interest in Superior Denver. Andrew Barrett holds 2% of the common units and Robert Neiman holds 10% of the common units. Northland Holding Trust indirectly holds an equity interest in Class B and C Preferred Units in Superior Denver through its ownership of a non-voting stock interest amounting to 90% of the stock of Superior Broadcasting Co., which, in turn, holds Class B and C units representing an equity interest of approximately 34.95%. Christopher Devine and Bruce Buzil each control 50% of the vote and assets of Northland Holding Trust as co-trustees. Christopher Devine holds an indirect equity interest in Superior Denver (i) through his ownership of 10% of the voting stock of Superior Broadcasting Co., which constitutes all of the voting stock of Superior Broadcasting Co., and his position as president and a director of Superior Broadcasting Co., (ii) by virtue of his position as a co-trustee with Bruce Buzil of Northland Holding Trust, which holds, as non-voting stock, the remaining 90% of the stock of Superior Broadcasting Co., and (iii) by virtue of Christopher Devine’s control of the assets and voting power of New Bedford Trust, which holds 54% of the common units of Superior Denver. Christopher F. Devine is the sole trustee of New Bedford Trust.¹ Superior Denver is the licensee of the following radio broadcast stations and FM translator station:
