JUDGMENT


On April 25, 2011, the petitioner filed the above-captioned legal action requesting that his uncle, Mr. Pedro Roman Collazo, be declared disabled, and that he be appointed his legal guardian. Said request was duly notified to the Family Advocate, who submitted an Advocate's Report.

Following compliance with service of process of the disabled and several related procedures, the hearing on the merits of the case was held on October 3, 2011. On said occasion, the appearing parties were petitioner Angel Roman Lopez, who appeared represented by Mr. Federico R. Ducoudray Acevedo, Ms. Maria de los A. Silva Basora, Family Advocate, and psychiatry expert Dr. Victor J. Llado.

The evidence presented in this case consisted of the expert testimony of Dr. Llado and the statements made by witnesses Ruth E. Roman Lopez and the petitioner. Specifically, in relation to the mental capacity and health condition of Mr. Pedro Roman Collazo (who is currently eighty-one (81) years old), Dr. Llado stated that he performed his psychiatric evaluation on August 3, 2011. He indicated that the patient has been diagnosed with dementia caused by Alzheimer's, and that he has symptoms such as memory loss and attention deficit, lack of orientation in time and space, diminishing ability to communicate, and deterioration of his mental capacity. Said condition caused a crisis which resulted in a recent hospitalization in the Pan American Hospital. The expert witness also stated that Mr. Pedro Roman Collazo suffers from diabetes, a prostate condition and depression. As of present, and on recommendation of the expert witness, Mr. Pedro Roman Collazo is interned in Hogar Vista Serena. Dr. Llado concluded that, from a medical perspective, Mr. Pedro Roman Collazo is completely unable to meet his basic needs, or to identify and value his assets; therefore, he needs complete and constant care and supervision in order to ensure his health, safety and well-being.

The evidence also revealed that Mr. Pedro Roman Collazo does not have a wife or children, and that his nephew, and party appearing herein, is the one who has taken care of all of his needs. The petitioner stated that he is willing to formally assume the responsibilities to care and protect his uncle and that he meets the qualifications necessary to administer his assets and businesses. For her part, Ms. Ruth E. Roman Lopez stated that she is in agreement with the petition filed by her brother to be appointed legal guardian of his uncle.

Based on the foregoing, and taking into consideration the favorable determination issued by the Family Advocate, we hereby decide that as of present Mr. Pedro Roman Collazo is unable to take care of himself or his assets. Therefore, the Court GRANTS the above-caption petition for declaration of disability, and appoints petitioner ANGEL ROMAN LOPEZ the legal guardian of PEDRO ROMAN COLLAZO for all legal purposes.

## CERTIFIED TRANSLATION

Petitioner must post a bond in the amount of FIFTEEN THOUSAND DOLLARS (\$15,000.00) in order to be able to act as legal guardian. In addition, he must file with the Court Yearly Guardianship Reports, along with the documents evidencing the income and expenses of the disabled and the sound administration of the assets of the latter.
