Dear Mr. Fasbender:

This is in reference to the request filed on July 14, 2021. CCBL requests a further extension of the STA originally granted in 1981 to continue operating using alternate 10 kW patterns to overcome Cuban interference, to allow time to file the required FCC Form 302 application to cover BP-20170406ADD.¹ In support of the request, we noted that additional time will be needed to build the new facility and file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is hereby GRANTED, and CCBL may continue to operate with the 10 kW patterns specified in BMML-20170426ACK using

the licensed site towers. CCBL must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commissions exposure guidelines. See 47 CFR § 1.1310. CCBL must resume licensed 5 kW operation if the Cuban interference ceases, or upon official notice from the Commission.

This authority expires on **February 2, 2022.**
