CHANGE OF AUTHORIZED COMMUNITIES STATEMENT
KEZZ BERTHOUD, COLORADO
KEVIN J. YOUNGERS

The applicant, Kevin J. Youngers, seeks to modify the CP of KEZZ (facility I.D. 165959, BNPH-20060310ADJ) at Walden, Colorado on channel 231C2, to minor change its authorized community from Walden to Berthoud, Colorado. He also seeks to change his transmitter location. He is proposing a change of channels and class of operation from 231C2 to 230A.

The minor change of the authorized community is pursuant to the new provisions of MB Docket 05-210 which becomes effective on January 19, 2007. This docket allows for city of license changes, under certain provisions, to be filed as a minor change application on FCC Form 301 for AM and FM broadcast stations.

Kevin J. Youngers believes this application meets the provisions under this new docket for a change in authorized communities for KEZZ. The docket emphasizes the desire to avoid any losses of service to communities while providing the most efficient usage of spectrum. KEZZ was acquired in auction 62 but has not yet been constructed. Therefore, if the authorized community is changed from Walden to Berthoud, Walden will experience no actual loss of service from what it is currently receiving and will continue at its present service level of nine primary signals from stations in other communities. The proposed new community, Berthoud, Colorado, does not have a commercial AM, FM or TV station authorized to it, thus, it will be the community's first local service. According to the U.S. Census data for 1990 and 2000, Berthoud has rapidly

grown from a population of 2,990 to a population of 4,839 while, conversely, Walden has been quickly declining from a population of 890 to a population of 734. Thus, the public interest supports a change of allotments from Walden, which will remain at its current licensed service level, while Berthoud will benefit from its first local service.

Under the Instructions for the FCC Form 301, under item 18, it calls for the following information to be included:

- 1) If new technical facilities are proposed, the area and population with the proposed 70 dbu and 60 dbu contours of the station: In this case, the population within the current contours of KEZZ at Walden is: 60 dbu – 14,634 persons and an area of 7,873 sq. km, 70 dbu – 1,500 persons and an area of 3,038 sq. km. The new proposed contours for KEZZ at Berthoud will be: 60 dbu – 459,801 persons and an area of 3,524 sq. km, 70 dbu – 228,524 persons and an area of 1,291 sq. km.
- 2) The number of stations licensed to the proposed new community of license: There is no commercial AM, FM or TV station licensed to Berthoud, Colorado. This will be the community's first local service.
- 3) The number of stations providing protected service to the proposed community of license: There are 21 Commercial FM stations that cover the new community with 60 dbu service or greater. There are 36 AM stations that cover the new community with 0.5 mv/m coverage or greater.
- 4) The population, according to the latest Census Data, of the proposed community of license: In this case, the community of Berthoud, Colorado, is 4,839 persons according to the 2000 U.S. Census data.

- 5) Where relevant to establish the precondition of a licensable community, a description of the civic, cultural, religious, social and commercial attributes of the proposed community of license: In this case, the proposed community of license, Berthoud, Colorado, is incorporated and has its own Post Office with a zip code of 80513. Berthoud is governed by a mayor, a mayor pro tem, and 5 trustees. Town government includes a town administrator, a town clerk, municipal judge, town attorney, director of public works, director of public planning, and several other officials. Berthoud has its own police department headed by the chief of police/town marshal and the Berthoud Municipal Court. Fire protection is provided by the Berthoud Fire Protection District. Berthoud has several physicians and medical clinics. It has many banks, restaurants, and over 18 churches. Berthoud has the Berthoud Public Library and the Little Thompson Valley Pioneer Museum Berthoud has a number of clubs and civic organizations. Berthoud has two newspapers, the Berthoud Recorder and the Berthoud Weekly Surveyor.
- 6) Any other information deemed relevant: There are four public schools in Berthoud: Berthoud High School, Turner Middle School, Ivy Stockwell Elementary, and Berthoud Elementary. There are also several daycare facilities in Berthoud. Berthoud has more than 6 parks and plans to build a new recreation center. The town's vision statement states, "A small, progressive community which endeavors to provide the quality of life enjoyed by past and present generations while ensuring its position for the future within the dynamic Front Range economic corridor. A town that works

together to control its own destiny by being proactive in planning for growth while preserving and enhancing its rural character.”
