

Multiple Ownership Information

A Commission grant of this application seeking the license assignment of Station KMUR (AM), Pryor, Oklahoma, to the Assignee would not violate the Commission's multiple ownership rules.

The Assignee is presently the licensee of KRVN (AM), Claremore, Oklahoma. The Assignee also presently brokers all of the time of the station which is the subject of this application. The city grade contours (5.0 mV/m) of KRVN and KMUR overlap one another. The combined audience share of the stations at issue are negligible and their combined revenue is a fraction of the Tulsa radio market.

The following information shows that no fewer than 31 existing commercial stations are located within the "Market" as defined by the Commission's rules. A list of those stations is shown herein, as well as a map depicting the Market, a map showing the commercial AM stations whose city grade contours penetrate the Market, and a map showing the commercial FM stations whose city grade contours penetrate the market.

The Commission rules allow for the ownership of seven stations, with no more than four in any one service, when 31 stations are present. Upon the grant of this assignment and the closing of this transaction, the Assignee will own two stations in the market. This is well within the Commission's ownership maximum under the multiple ownership rules and is in compliance with the rules and policies of the Commission.

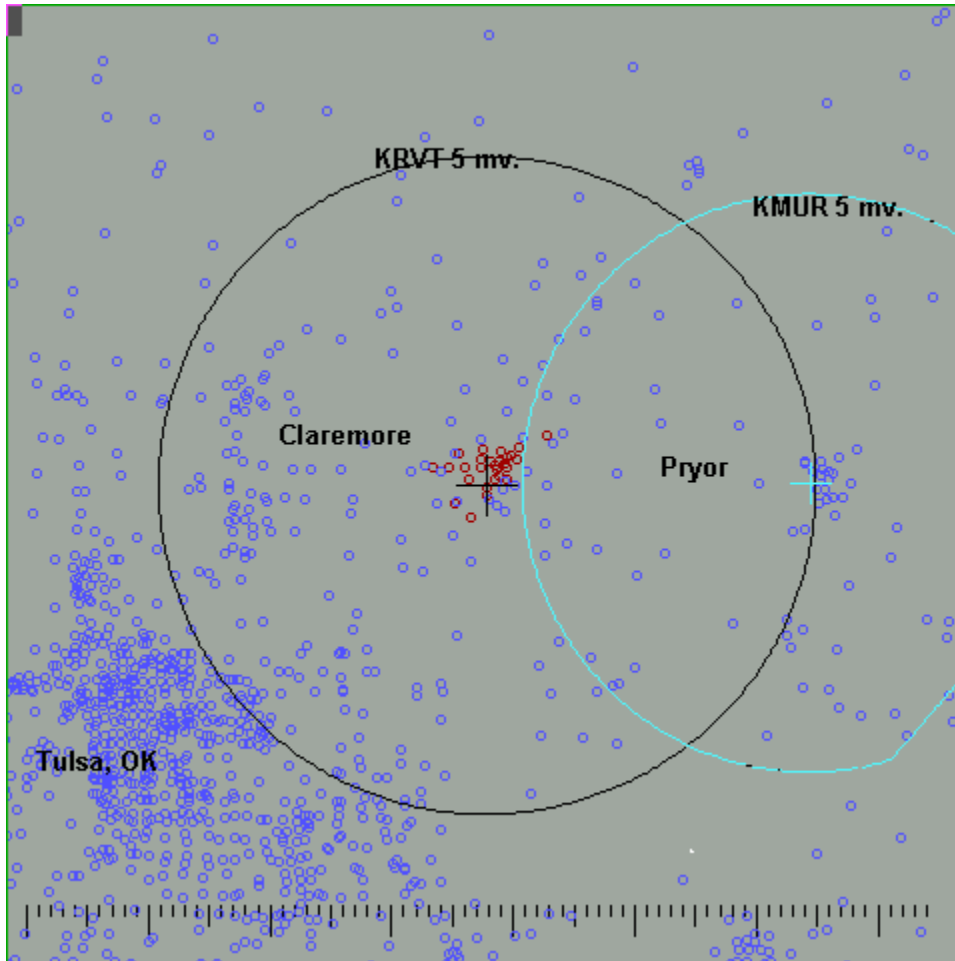

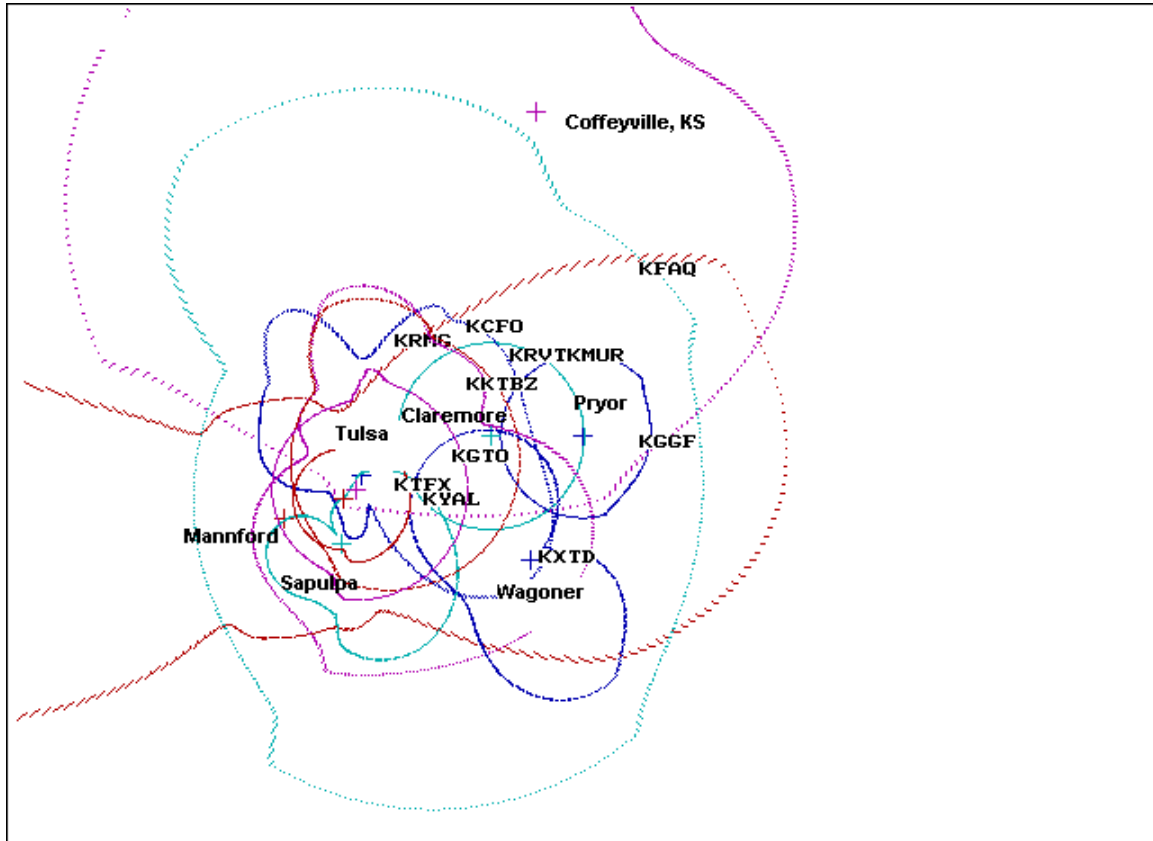
