EXPLANATION OF FILINGS

The principal owner of the current licensee of Momentum Broadcasting LLC and Alpine Broadcasting Corporation was Norman R. Alpert. Mr. Alpert passed away recently and the Probate Court appointed his wife, Donna L Alpert, and his daughter, Laura Lee Lamparyk, as co-Personal Representatives. (See exhibit).

Earlier filings for WAVV, WTNQ and WJRV have been made transferring control from Norman R. Alpert to the Norman R. Alpert Estate for both entities and the three stations.

The purpose of this and other filings is to transfer control of the licensees of Momentum Broadcasting LLC and Alpine Broadcasting Corporation from the Norman R. Alpert Estate to the Norman R. Alpert Trust.

The ultimate control will be in the Norman R. Alpert Trust, with Donna L. Alpert and Laura Lee Lamparyk, as Trustees. The minority member's interest will not change. The Licensees' names will not change, remaining Momentum Broadcasting LLC and Alpine Broadcasting Corporation.


AGREEMENT
