TECHNICAL STATEMENT

1. This Technical Statement and attached exhibits were prepared on behalf of Miller Communications, Inc. ("Miller"), licensee of WQKI-FM, Channel 239A, Orangeburg, South Carolina. Miller is making changes in the WQKI-FM facility thereby triggering this Radio Market Analysis to determine compliance with §73.3555 of the Commission's multiple ownership rules. Miller is also the licensee of FM Stations: WFRK, Channel 237A, Quinby, South Carolina; WGFG, Channel 287C3, Branchville, South Carolina; WIBZ, Channel 238A, Wedgefield, South Carolina; WSCZ, Channel 230C3, Winnsboro, South Carolina; WSIM, Channel 229A, Lamar, South Carolina; WWBD, Channel 234C3, Sumter, South Carolina; and WWKT-FM, Channel 257C3, Kingstree, South Carolina, as well as AM Stations: WDKD, 1310 kHz, Kingstree, South Carolina; WDXY, 1240 kHz, Sumter, South Carolina; WHYM, 1260 kHz, Lake City, South Carolina; WOLH, 1230 kHz, Florence, South Carolina; and WWHM, 1290 kHz, Sumter, South Carolina. WQKI-FM is not located within a metro market, nor is it home to any metro market; therefore, this review will verify compliance of commonly owned stations in a non-rated market.

2. Exhibit #1 is a map of South Carolina showing the 70 dBu contours of Miller's FM stations¹ and the 5.0 mV/m contours of Miller's AM stations. Changes to WQKI-FM impact

only one contour overlap market. Radio Market #1 consists of FM stations WQKI-FM and WGFG.

CONTOUR OVERLAP REVIEW - RADIO MARKET #1

3. Radio Market #1 is made up of FM Stations WQKI-FM and WGFG. The city grade contours of the two subject stations WQKI-FM and WGFG.

4. Radio Market #1 combined contours will be used to determine the number of other stations in the market to which the number of subject stations in each market will be added to reach the total number of stations in or providing service to the respective markets. No stations with transmitters located more than 92.0 kilometers from the boundary of the common overlap of the subject stations will be considered. Further, no other facility controlled by Miller will be considered as a market contributor unless it is a subject station in the radio market under study.

5. Exhibit #2 is a depiction of the AM and FM stations (commercial and non-commercial) providing service to the Radio Market #1 boundary. There are eleven other stations depicted. Exhibit #3 is a tabulation of the stations in Radio Market #1. There is a total of thirteen shown in the market, including the two subject stations. The number of stations indicated falls in the fourteen or fewer stations tier of §73.3555(a)(1)(iv) of the Commission's rules. At this level, common ownership or control of up to five commercial stations with no more than three in the same service, is permissible. Therefore, Miller is in compliance in Radio Market #1.

6. Based on the compliance shown in non-rated market, the proposed changes to WQKI-FM are in compliance with §73.3555 of the Commission's rules, with regard to the markets reviewed.

7. The foregoing technical statement was prepared on behalf of Miller Communications, Inc. by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.6 BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.





