On behalf of Multimedia Holdings Corporation ("Multimedia"), licensee of TV translator K61FB, Globe-Miami, Arizona (Facility ID #35487), hereby files an application for Extension of Special Temporary Authority (STA) to operate on digital displacement Channel 48 pending the grant of its Construction Permit displacement application for operation on Channel 48 which was filed with the FCC on October 22, 2009 (FCC File No. BDISDTT 20091022AAQ). The temporary call sign of K48MJ-D was assigned.

The history of the CP application and subsequent STAs is as follows:

1. The original STA (original FCC File No. BLSTA-20100629ATT) was granted June 30, 2010, to expire December 30, 2010.
2. Multimedia filed for an extension of the original STA on November 30 (BELSTA-20101130AAN), which was granted on December 1, 2010. It will expire June 30, 2011 (attached).

For reasons explained below, the necessity for this extension is due to delays in processing the CP application, *beyond the control of Multimedia*.

First, to date, the Construction Permit application remains pending at the FCC. The FCC's International Bureau referred this application to the Mexican government for clearance because the translator is located within the FCC's benchmark proximity for LPTV UHF proposals -- 275 km from the U.S./Mexican border. To date, the Mexican government has not provided such clearance.

Second, while the Mexican government has been evaluating this proposal, as the Commission is aware, wireless services such as Verizon Wireless have received authorization to deploy operation in the 700 MHz band. During the summer of 2010, Verizon Wireless commenced testing and deployment its new 700 MHz band operation in the Phoenix area (which includes the Globe-Miami area). Engineering tests and interference analyses revealed that Multimedia and Verizon may mutually and adversely interfere with each other with Verizon's operation on 700 MHz in Globe-Miami if Multimedia continues to operate this translator on Ch. 61. To avoid this potential interference, and to permit Verizon to operate in the Globe-Miami area as authorized pending Mexican approval and grant of Multimedia's Construction Permit for operation on Ch. 48, FCC staff in the Media Bureau and International Bureau recommended that Multimedia obtain an STA for operation of K61FB on Ch. 48. The STA was granted

June 30, 2010 and expires December 30, 2010, as noted above. Accordingly, Multimedia vacated the Ch. 61 frequency to accommodate Verizon's service during the summer of 2010.

Neither Multimedia nor any party to this request is subject to denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. § 853a.
