

FCC 314 ASSIGNMENT APPLICATION

Logan 12, Inc. ("Logan 12"), Price Broadcasting, Inc. ("Price") and Univision Television Group, Inc. ("Univision") have entered into an Asset Purchase Agreement dated April 7, 2006, whereby Univision will acquire the assets and license of full power television station KUTF(TV), Logan, Utah, from Logan 12, Inc. and the assets and license of low power television station K45GX, Salt Lake City, Utah from Price. Attached hereto is the Asset Purchase Agreement, a list of the schedules and justification for their exclusion. The schedules to the agreement have been omitted because they do not reflect the legal or other qualifications of the parties, nor do they contain information relevant to whether the structure of the transaction complies with the Commission's Rules. Therefore, the schedules need not be submitted to the Commission as part of this Application, but the parties will submit such information upon the Commission's Request. *See LUJ, INC. AND LONG NINE, INC.*, 17 FCC RCD 16980 (2002) and *Public Notice*, 17 FCC RCD 16166 (2002).
