**Application for Assignment of License**  
**Informal Objection**

Dear Applicants, Counsel, and Mr. Davis:

We have before us the above referenced application (Application) for Commission consent to the proposed assignment of the license for KJJB(FM), Eagle Lake, Texas (KJJB or the Station), from Jennifer Cremeens (Cremeens) to Centro Cristiano de Vida Eterna (CCVE). We also have before us an Informal Objection (Objection) to the Application, filed on October 18, 2018, by James B. Davis (Davis).<sup>1</sup> For the reasons set forth below, we deny the Objections and grant the Application.

*Background.* On October 5, 2018, Cremeens filed the subject Application, seeking Commission consent to assign the Station's license to CCVE. Cremeens subsequently notified the Commission that KJJB was silent and requested permission for the Station to remain silent<sup>2</sup> pending action on the assignment Application. In his Objection, Davis claims that KJJB was never constructed and that "there is reason to suspect that false information was attested to on many KJJB Applications."<sup>3</sup> In support of its allegations, Davis submits a list of previous modification applications and requests to remain silent, filed

with the Commission from 2007 to the present.<sup>4</sup> Davis also notes that Cremeens previously filed an application to assign the Station's license to S Content Marketing LLC (S Content),<sup>5</sup> but the assignment was never consummated.<sup>6</sup> Davis claims that he "personally spoke with the President of S Content Marketing to find out reasons why the sale of KJJB 95.3 did not go through. He stated KJJB had never been constructed or built out."<sup>7</sup> Accordingly, Davis urges the Commission to investigate his allegations, issue a Letter of Inquiry "to be sure its rules are being observed," and delay action on the Application.<sup>8</sup> In its Opposition, CCEV asserts that "the sole inquiry in this proceeding is the qualifications of the proposed assignee to become licensee of Station KJJB(FM)" and that Davis has not provided facts sufficient to show that grant of the Application would be *prima facie* inconsistent with the public interest, convenience, and necessity.<sup>9</sup>

*Discussion.* Section 310(d) of the Communications Act of 1934, as amended (the Act)<sup>10</sup> requires the Commission to determine whether the proposed assignment of a broadcast license would be in the public interest. Informal objections, like petitions to deny, must provide properly supported allegations of fact that, if true, would establish a substantial and material question of fact that grant of the application would be *prima facie* inconsistent with the public interest, convenience, and necessity.<sup>11</sup> Davis has not satisfied this threshold requirement.

In his Objection, Davis does not argue that CCVE is not qualified to become a Commission licensee, nor has Davis provided any evidence that the proposed assignment violates the public interest. Rather, the central issue raised here relates to Davis's belief that the Station was never constructed and that Cremeens has not been truthful and forthcoming. Davis, however, neglects to submit concrete evidence to support his suspicions. Rather, Davis's "evidence" consists solely of a list of applications previously filed with the Commission and a hearsay account of a conversation with the President of S Content, the former proposed assignee of the Station.<sup>12</sup> Allegations based on speculation and hearsay do not establish a *prima facie* case requiring further investigation.<sup>13</sup>

We, therefore, find that Davis has failed to raise a substantial and material question of fact calling for further inquiry. We also find that Cremeens is qualified to assign the Station, CCVE is qualified to

hold the Station's license, and that grant of the Application is consistent with the public interest, convenience, and necessity

*Conclusion/Actions.* Accordingly, IT IS ORDERED that the Informal Objections, filed October 18, 2018, and December 11, 2018, by James B. Davis ARE DENIED.

IT IS FURTHER ORDERED, that the Application for the Assignment of License for Station KJJB(FM), Eagle Lake, Texas (File No. BALH-20181005ABW), from Jennifer Cremeens to Centro Cristiano de Vida Eterna IS GRANTED.
