Dear Counsel:

This is in reference to the request filed December 26, 2012, on behalf of Adelante Media of Utah License, LLC ("Adelante"). Adelante requests further extension of the special temporary authority ("STA") granted on April 13, 2011, to operate Station KDUT with reduced power.<sup>1</sup> In support of the request, Adelante states that it has the repair parts in hand but has been prevented from completing repairs at its transmitter site by adverse winter weather conditions at the site. Adelante expects that repairs can be completed in January or February.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

<sup>1</sup> KDUT is licensed for operation on Channel 272C (102.3 MHz) with effective radiated power of 89 kilowatts (H only) and antenna height above average terrain of 647 meters.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KDUT may continue to operate with reduced power. Adelante must notify the Commission when licensed operation is restored. Adelante must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **July 14, 2013**. We expect that further extensions of this STA will not be necessary.
