

## MULTIPLE OWNERSHIP COMPLIANCE STUDY

**KJJB (FM)**  
Eagle Lake, Texas  
August 2016

This Multiple Ownership Compliance Study was conducted to determine if Roy E. Henderson can acquire KJJB (FM) (Facility ID 171037) at Eagle Lake, TX and still be in compliance with §73.3555 of the Commission's Rules. KJJB (FM) also has a Construction Permit (File No. BPH-20140710AAB). Eagle Lake, TX is not located in any BIA Metro; therefore this study utilizes the Commission's Interim Contour-Overlap methodology.

In addition to KJJB (FM), the applicant has common ownership with the following stations:

**KNVR (AM)**, San Saba, TX (Facility ID 65316)  
**KNUZ (FM)**, San Saba, TX (Facility ID 65315) – Has a Construction Permit (BPH-0160601ABG)  
**KLTR (FM)**, Brenham, TX (Facility ID 40775) – Has a Construction Permit (BPH-20120529ADT) at Hempstead, TX  
**KTWL (FM)**, Hempstead, TX (Facility ID 21204) – Has a Construction Permit (BMPH-20160510AAU) at Todd Mission, TX  
**KNRG (FM)**, New Ulm, TX (Facility ID 15113) – Has a Construction Permit (BPH-20141024ACK)  
**KJAZ (FM)**, Point Comfort, TX (Facility ID 6022)  
**KULM-FM**, Columbus, TX (Facility ID 70706)  
**KHTZ (FM)**, Ganado, TX (Facility ID 27619)  
**KROY (FM)**, Palacios, TX (Facility ID 77693)  
**KEMA (FM)**, Three Rivers, TX (Facility ID 31640)


All attributable stations are shown in Exhibit #1.

KJJB (FM) has 70 dBu contour overlap with KNRG (FM) and KULM-FM, forming one radio market. These subject stations are shown in Exhibit #2. All AM and FM services to the subject area are shown in Exhibit #3. Exhibit #4 is a tabulation of all services to the subject area. The contour maps show a total of 10 services, including

the 3 subject stations (all FM). §73.3555(a)(1)(iv) states that a person or single entity (or entities under common control) may have a cognizable interest in licenses for AM or FM radio broadcast stations


*In a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM); provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station.*

Based on these findings, it is believed that the ownership of these three subject stations by Roy E. Henderson is in compliance with §73.3555 of the Commission's Rules. All statements contained herein are thought to be accurate and correct to the knowledge of the undersigned.




