Declaration Concerning Compliance with Radio Duopoly Rules

I, John J. Mullaney, declare and state that I am a graduate electrical engineer with a B.E.E. and my qualifications are known to the Federal Communications Commission, and that I am an principal engineer in the firm of Mullaney Engineering, Inc., and that I have provided engineering services in the area of telecommunications since 1977. My qualifications as an expert in radio engineering are a matter of record with the Federal Communications Commission.

The firm of Mullaney Engineering, Inc., has been requested to prepare the instant engineering exhibit which demonstrates that the proposed LMA / Acquisition of KTCM 262C3 - Kingman, KS, in addition to the four other FM stations controlled by Ad Astra Per Aspera Broadcasting, Inc. is in compliance with the Radio Duopoly Rules. Since none of the five stations are in a rated Arbitron Market the contour overlap method is being used.

Figure A is a map showing the 70 dBu city grade contour of all five FM stations. The 70 dBu city grade contour of KTCM(FM) **does not overlap** the city grade contour of any other commonly owned station. All contours are based upon information taken from a recent version of the FCC's CDBS data base. Although not currently in that data base, KGGG is in the process of preparing a minor modification of its CP (0.85 km move). This proposed modification has been included in this exhibit.
