OTHER AUTHORIZATIONS

Simmons Media Group, LLC ("SMG")

SMG is the ultimate parent of (1) Simmons-SLC, LS, LLC ("SSLC"); (2) Simmons-Austin, LS, LLC ("SA"); and (3) Western Broadcasting, LS, LLC ("WB"). As discussed in more detail in Exhibit 5, SSLC, SA, and WB are filing concurrent applications on FCC Form 315 in connection with the reorganization of SMG pursuant to the Restructuring Agreement attached hereto at Exhibit 6. As part of the restructuring of SMG, two stations currently licensed to SSLC – KDWY(FM), Diamondville, WY (Fac. ID No. 77947) and KEGH(FM), Brigham City, UT (Fac. ID No. 21607) – must be assigned to divestiture trusts. In addition, several applications on FCC Form 314 (together, the "Millcreek/3 Point 314s") are being submitted concurrently herewith to seek FCC consent to certain other transactions contemplated by the Restructuring Agreement.¹ These additional transactions are planned to close at the same time as the restructuring of SMG.
