Agreements for Sale of Station

The following agreements are attached hereto:

- Asset Purchase Agreement dated as of September 4, 2002 (the “Purchase Agreement”), among Paxson Communications of Boston-60, Inc., Paxson Boston License, Inc. (“Assignor”), and NBC Subsidiary (NH), Inc. (“Assignee”), pursuant to which Assignor agrees to sell and convey to Assignee the FCC authorizations for WPXB(TV) and WPXB-DT, Merrimack, New Hampshire (the “Stations”), and substantially all of the other assets used or useful in the business and operations of the Stations.
- Escrow Agreement dated as of September 4, 2002, among NBC Subsidiary (NH), Inc., Paxson Communications of Boston-60, Inc., Paxson Boston License, Inc. and Wachovia Bank, National Association

The Purchase Agreement, including the Schedules and Exhibit thereto, and Escrow Agreement comply fully with the Commission’s rules and policies. The Purchase Agreement and Escrow Agreement attached hereto embody the complete and final understanding between the Assignor and Assignee with respect to the sale of the Stations, except that the Purchase Agreement does not include copies of the following Schedules and Exhibit:

The above Schedules, which are customarily included with agreements for the sale of broadcast stations, include lists of the assets that will be conveyed to Assignor and provide information regarding certain aspects of the business and operations of the Stations. For example, Schedule 3.5 is a list of the real property leases for the Stations' transmitter site, Schedule 3.6 is a list of the equipment and other property used in the operation of the Stations, and Schedule 3.10 is a description of the insurance policies for the business and operation of the Stations. Exhibit A is a copy of the form of legal opinion to be delivered by Assignor's counsel upon the closing under the Purchase Agreement.

Some of the information in the Schedules is proprietary business information that is not publicly available. Neither the Schedules nor Exhibit contain information that is material to the Commission's consideration of the instant application. Accordingly, in accordance with the Media Bureau's *Public Notice* released on August 22, 2002 (DA 02-2049), Assignor has not included with this Application, nor placed in the public inspection file, copies of the Schedules and Exhibit listed above. If requested by the staff, Assignor will provide copies of those Schedules and Exhibit.
