

RADIO-TELEVISION CROSS OWNERSHIP STATEMENT

Under the Radio-Television Cross Ownership Rule currently in effect, 47 C.F.R. § 73.3555(c) ("Section 73.3555(c)"), the Commission has authorized the Media Bureau to allow ownership of up to two television stations and six commercial radio stations, subject to compliance with the local radio ownership limits, if at least "20 independently owned voices would remain in the market" (the "20-Voice Test").¹ Also, under Section 73.3555(c), if a party could own two television stations and six commercial radio stations, it instead may own one television station and seven radio stations, subject to compliance with the local radio ownership limits.

For purposes of the 20-Voice Test, the Commission has identified each of the following as an independent voice:

- any independently owned and operated full power television station within the DMA of the television station's community of license;
- any independently owned full power radio station (commercial or noncommercial) that is either located in or has a reportable Arbitron share in the radio metro market where each relevant broadcast station is located;
- any English-language newspaper published at least four days a week within the television station's DMA and that have a circulation exceeding 5 percent of the DMA's households; and
- one cable system, if the cable service is "generally available to households in the DMA."

The following one television station in the Harrisburg-Lancaster-Lebanon-York, PA DMA and six radio stations in the Harrisburg-Lebanon-Carlisle, PA Arbitron Radio Metro are currently under common control, through ownership by subsidiaries of Clear Channel Communications ("CCC"):

² This DMA does not have eight independent television voices; however, as an LMA entered into prior to November 5, 1996, this two television station combination is grandfathered at least until the outcome of the biennial (now quadrennial) review. See, e.g., *Shareholders of AMFM, Inc.*, 15 FCC Rcd 16062, 16074, n.28 and 16075 (2000).

This existing combination of two television stations and six radio stations is a grandfathered combination pursuant to 47 C.F.R. Section 73.3555(c). This instant statement regarding Section 73.3555(c) is being provided in connection with an application for a construction permit for the minor modification of radio station WRBT(FM), Harrisburg, PA. Also being submitted with such minor modification application is a showing that this combination of six radio stations complies with the local radio ownership limits.

Counting independent broadcast voices, the Harrisburg-Lebanon-Carlisle, PA Market has at least 22 independent broadcast voices. In addition, there are at least three English-language newspapers published at least four days a week within the subject DMA that have a circulation exceeding five percent of the DMA's households, plus one voice may be counted for cable service being generally available to households in the DMA, for a total in 26 independent media voices.
