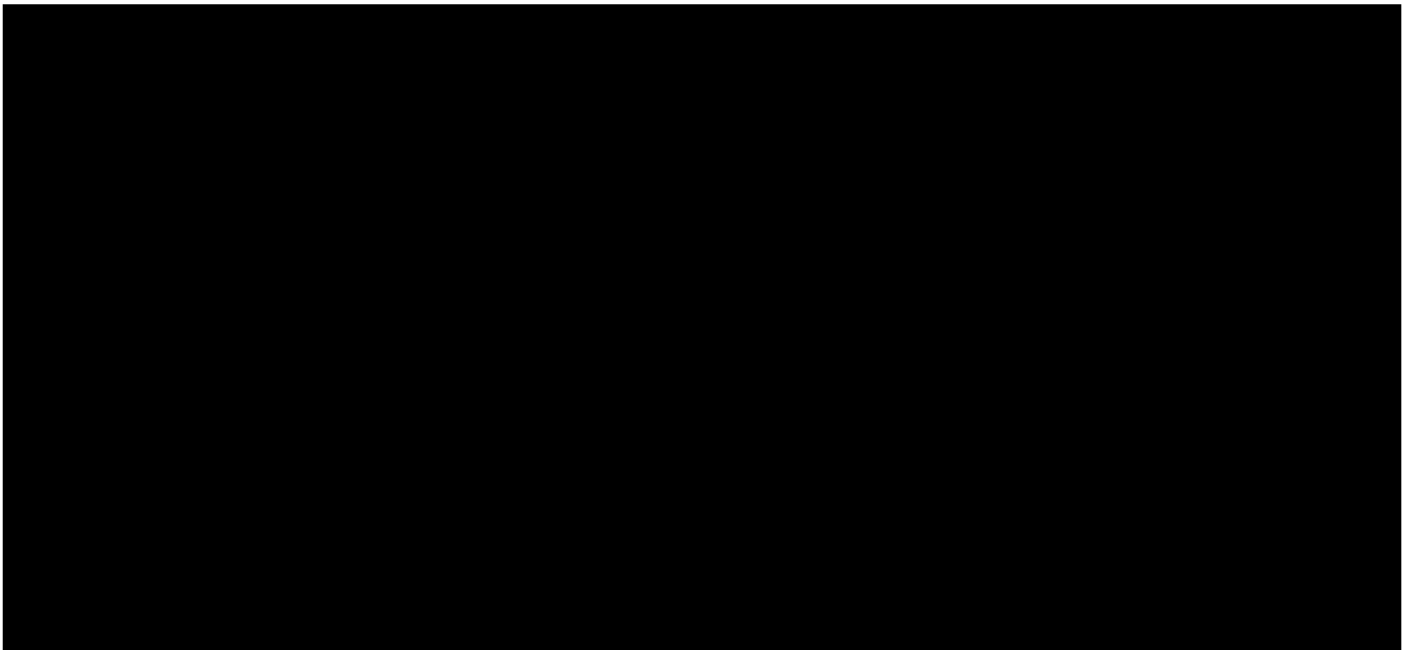

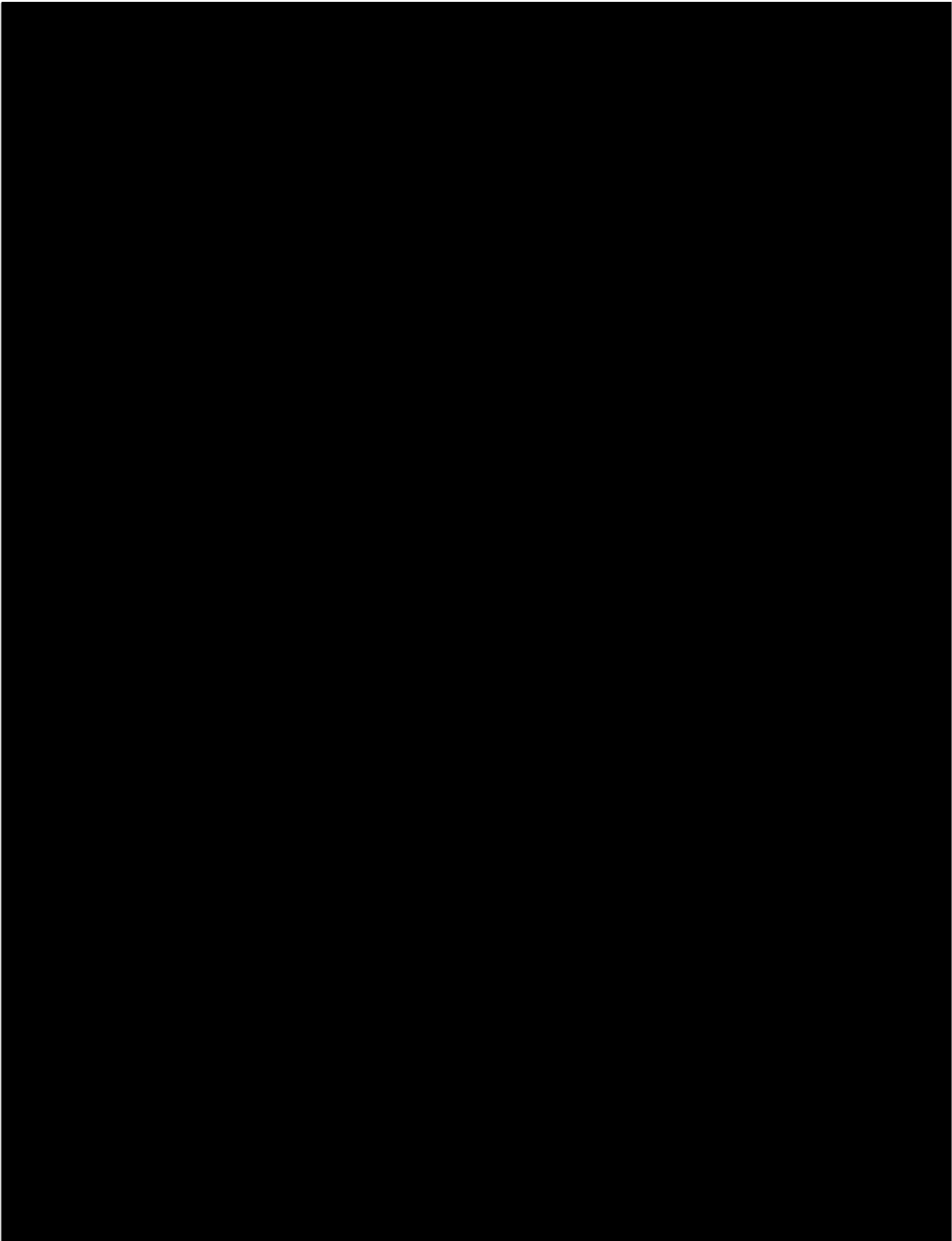

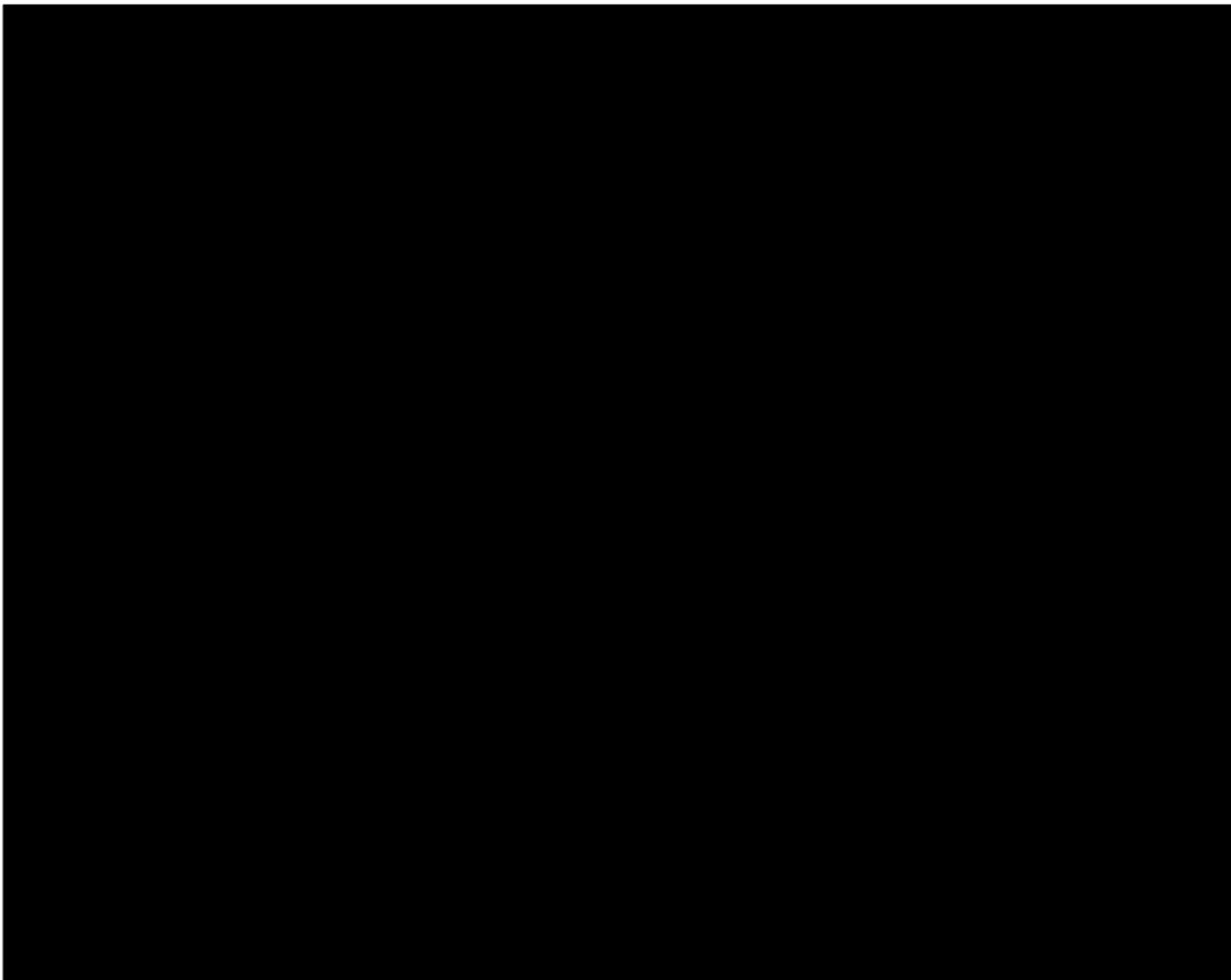
The Grantor hereby amends the Trust terms and provisions in their entirety to read hereafter as follows:
