K295AJ, NORTH LAS VEGAS, LICENSEE CSN INTERNATIONAL WILL CONTINUE TO TAKE AN OFF THE AIR SIGNAL FEED FROM K211DC, PAHRUMP OWNED BY LICENSEE CALVARY CHAPEL OF TWIN FALLS, INC. **Please Note that Authorization BPFT-20020415AAY has been turned in and requested to be dismissed without prejudice (see attachment letter).**

Request of Waiver of Section 74.1231(b):

THE COMMISSION'S RECORDS SHOULD INDICATE THAT, AS A RESULT OF ASSIGNMENT APPLICATION BALFT-19980520ED (GRANTED DEC 11, 1998) CSN ACQUIRED K295AJ FROM ADVANCED MINISTRIES D/B/A NEW LIFE CHRISTIAN SCHOOL. AS PART OF THE ASSIGNMENT APPLICATION PROCESS, ON JULY 7, 1998, CSN FILED TWO SUBMISSIONS THAT CLEARLY DISCLOSED THE RELATIONSHIP BETWEEN CSN INTERNATIONAL (CSN) AND CALVARY CHAPEL OF TWIN FALLS, INC. (CCTF):

A. AN 'AMENDMENT TO PENDING APPLICATION' WHICH INDICATED, IN PART, THAT 'THE PRIMARY SERVICE STATION FOR NOW K295AJ IS RADIO STATION KAWZ-FM AT TWIN FALLS, IDAHO, WHICH IS OWNED AND OPERATED BY CCTF. CCTF IS AN AFFILIATE COMPANY OF CSN.

B. A 'CHANGE OF PRIMARY SERVICE STATION DESIGNATION' WHERE IT WAS CLEARLY DISCLOSED THAT, UPON CONSUMMATION OF THE PURCHASE OF NOW K295AJ, CSN WOULD CHANGE THE PRIMARY SERVICE STATION TO CCTF'S KAWZ-FM.

BECAUSE THE COMMISSION IS FULLY AWARE OF THE AFFILIATION BETWEEN CSN AND CCTF AND THE ORIGINAL ASSIGNMENT APPLICATION WAS GRANTED AND SINCE THEN THREE OTHER MODIFICATION

APPLICATIONS WERE ALSO GRANTED, CSN INTERNATIONAL IS REQUESTING THAT BECAUSE THIS APPLICATION COMPLIES WITH THE SPIRIT AND INTENT OF SECTION 74.1231(B) THIS MINOR CHANGE APPLICATION ALSO BE GRANTED.
