Further to this Court's Order Approving Settlement in the above-captioned matter, the Court makes the following, further findings:

1. The Court finds that the Parties have complied with all conditions and terms of the "Settlement Agreement" which was approved by this Court on July 30, 2010; in particular, the appropriate Parties and signatories have satisfied the requirement of executing a "Business Settlement" as defined in Paragraph 8 of the Settlement Agreement.

2. Good cause exists to allow the transfers contemplated in Paragraph 4 of the Settlement Agreement.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

1. All legal and equitable interests held in the above-captioned Trust Estate regarding

1 (i) Sainte Partners, II, L.P., (ii) Sainte 51, L.P., (iii) C&N Broadcast Division, Inc. and (iv) Sainte
2 Network Corporation (hereafter collectively referred to as the "Business Entities") are distributed,
3 free of trust, to Roxanne Storey, Laura Castro and Lorna Macintosh, in equal shares.

4 2. All legal and equitable interests held in the above-captioned Trust Estate regarding
5 that certain promissory note (a copy of which is attached hereto as Exhibit "A") is distributed,
6 free of trust, to Roxanne Storey, Laura Castro and Lorna Macintosh, in equal shares.

7 3. All funds transferred to this Court in the initial amount of Three Million Dollars
8 (\$3,000,000.00), plus all accrued interest, shall be released, transferred and returned to Ann-
9 Lesley Smith, in her capacity as trustee for the above-captioned trust.

10 4. The transfers of property interests described in Paragraphs 1 through 3 shall be
11 immediately effective as of the filing of this Order; however, the parties shall also cooperate in
12 executing any additional and necessary documentation or instruments to consummate such
13 transfers.




