

**MULTIPLE OWNERSHIP
EXHIBIT 5**

According to the Commission's local ownership "tiers," in a Metro reported by BIA as having between 30 and 44 (inclusive) commercial and noncommercial educational full-power radio stations, a party may have a cognizable interest in up to 7 commercial full-power radio stations, not more than 4 of which are in the same service (AM or FM). In the Oklahoma City, Oklahoma Arbitron Metro there are 39 commercial and noncommercial educational full-power radio stations. This application complies with the local radio ownership portion of the multiple ownership rules set forth in 47 C.F.R. Section 73.3555 because only four full-power radio stations (KMGL(FM), KOKC(AM), KOMA(FM), and KRXO(FM)) are attributable to Renda Broadcasting Corp. of Nevada and any party to this application.

In addition, the principal community contour of Station KOMA(FM) does not overlap the principal community contour of any full-power commercial or non-commercial radio station that (i) is not located within the Oklahoma City, Oklahoma Arbitron Metro and (ii) is attributable to Renda Broadcasting Corp. of Nevada or any party to this application.
