

AGREEMENT

TV RED DE PUERTO RICO, INC., applicant of new DLPTV stations: channel 19 Cataño, PR BNPDTL-20090825ARJ; channel 47 Ciales, PR BNPDTL-20090825BIB; channel 48 Guayanilla, PR BNPDTL-20090825BLW; channel 19 Luquillo, PR BNPDTL-20090825ARJ; and WANDA ROLON, licensee of WSJN-CA, Channel 20 in San Juan, PR and licensee and applicant for CP modification of WQSJ-LP, Channel 48 in Quebradillas, PR BMPDTA-20090824AJZ, hereby agree to the following:

WANDA ROLON accepts the use by TV RED DE PUERTO RICO, INC of a "full service mask" for the analysis of predicted interference for the above-referenced applications and subsequent modifications to confirm compliance with FCC requirements of no prohibitive interference. WANDA ROLON accepts the predicted interference to be caused to WQSJ-LP, Channel 48 in Quebradillas, PR BMPDTA-20090824AJZ by the TV RED proposed channel 48 Guayanilla, PR BNPDTL-20090825BLW or subsequent modifications.

TV RED DE PUERTO RICO, INC accepts the use by WANDA ROLON of a "full service mask" to confirm compliance with FCC requirements of no prohibitive interference for the above-referenced WANDA ROLON applications or subsequent modifications - caused to any TV RED DE PUERTO RICO, INC application and accepts the interference predicted to be caused to the TV RED DE PUERTO RICO, INC proposed channel 48 Guayanilla, PR BNPDTL-20090825BLW or subsequent modifications by the CP mod application of WQSJ-LP, Channel 48 Quebradillas, PR BMPDTA-20090824AJZ.


TV RED DE PUERTO RICO, INC accepts any interference that may be predicted by future changes undertaken by WQSJ-LP and commits to promptly undertake whatever corrective actions are required to eliminate any objectionable interference that may experienced by WQSJ-LP as a result of the facilities constructed by TV RED DE PUERTO RICO, INC on the basis of this agreement. These actions will include, but not are not limited to: reduction of power, antenna pattern change, better out-of-channel emissions filtering and/or amendment of the proposed channel 48 Guayanilla, PR BNPDTL-20090825BLW or subsequent modifications, as necessary to eliminate any objectionable interference.


Both parties to this agreement pledge mutual cooperation to resolve any actual objectionable interference problem that may be experienced by either party as a result of this agreement.
