To Whom It May Concern:

This letter supports the Application of Susan Bushell for Special Temporary Authority to have four FM Translators go silent. Mrs. Bushell mailed a Notice of Temporary Discontinued Service on October 6, 2016; a true and correct copy of the letter and death certificate of Mr. Bushell are attached. Because negotiations will continue longer than the 30 days allowed, Mrs. Bushell requests permission to have the below 4 translators remain silent for 180 days pursuant to the staff's discretion under 47 C.F.R. Section 73.1740. This application is for silent station authority, and is therefore exempt from application filing fees.

Richard Bushell was the license holder for four FM Translator licenses, Call Signs K242AT, K257BE, K265CY, and K276BR. These 4 licenses are now associated with FRN 0025872037. Mr. Bushell passed away on June 27, 2016.

Our client, Susan Bushell, is the surviving spouse of Mr. Bushell. Mrs. Bushell is in the process of taking title to the four FM Translator licenses. Our firm filed a Spousal Property Petition, which is scheduled to be heard on November 8, 2016, at 1:30 p.m. Once the Spousal Property Petition is resolved, our client plans to file Form 316 to complete the transfer of interest for all 4 licenses.

Prior to September 2016, Educational Media Foundation ("EMF") was the primary broadcasting station and contracted with Mr. Bushell for the use of these four translators. On September 12, 2016, EMF sent Mrs. Bushell written notification that it would no longer contract for the use of the four translators, effective September 30, 2016.

Because of EMF's discontinuance, Mrs. Bushell has been negotiating with other primary broadcasters. These negotiations cannot be concluded until after the Spousal Property Petition on November 8, 2016, and the Form 316 Transfer of Interest. Therefore, Mrs. Bushell requests 180 days to transfer the licenses and complete the negotiations with other primary broadcasters.

On September 12, 2016, EMF sent Mrs. Bushell written notification that it would no longer contract for the use of the four translators, effective September 30, 2016.

Because of EMF's discontinuance, Mrs. Bushell is in the process of negotiating with other primary broadcasters. While these negotiations take place, the translators will not rebroadcast other stations and Mrs. Bushell will temporarily discontinue operation until October 30, 2016. If the translators are silent past 30 days, Mrs. Bushell will apply for Special Temporary Authority with the FCC Audio Division.
