

## AMENDMENT TO ASSET PURCHASE AGREEMENT

This is an Agreement to amend the Asset Purchase Agreement ("Agreement"), dated April 27, 2003, by and between INSPIRATION TELEVISION, INC. ("Inspiration") and COMBINED COMMUNICATIONS, INC. ("Combined").

WHEREAS, the above named parties entered into the afore-referenced Agreement for the purchase and sale of the assets and permit for TV Translator K41HA, Bend, Oregon from Inspiration to Combined (see ME 20030430ABN).

WHEREAS, an application was filed with the Federal Communications Commission ("FCC") on April 30, 2003 seeking the Commission's consent to the assignment of the construction permit, including Exhibit 4, a copy of the Asset Purchase Agreement dated April 27, 2003, by which the permit and facilities are to be conveyed to Combined.

WHEREAS, the language of that Agreement mistakenly referred to *Consolidated* Communications, Inc. as the Buyer, instead of *Combined* Communications, Inc.


NOW, THEREFORE, the parties agree as follows:

1. The correct name of the purchasing entity is Combined Communications, Inc. and the afore-referenced Agreement is amended to reflect Combined as the Buyer of the station and assignee of the permit.
2. That the application for the consent of the FCC presently pending before that agency shall be amended to reflect the correct name of the Buyer and Assignee of the K41HA permit.
3. Buyer and Seller further agree that this Amendment to Asset Purchase Agreement may be executed in counterpart.
