

Exhibit 38 -- Explanation of Circumstance and Need  
for Special Temporary Authorization

Family Worship Center Church, Inc., ("FWCC") the Noncommercial Licensee of FM translator DW208BC, Corning, New York (Facility ID No. 106548)("Station") does hereby respectfully request Special Temporary Authority ("STA") in which to operate the Station for a period of **180 days**, or until the Station license renewal application is approved whichever comes first.

FWCC has over 75 broadcast facilities (full service and translators) located throughout the country. Each of FWCC facilities are properly permitted, licensed and where applicable, renewed, with the *exception* of this Station in question. License renewal applications for the State of New York were due to be filed with the FCC by February 1, 2006. Thru a *simple clerical error*, this renewal application filing deadline was missed by FWCC and the license to the Station subsequently expired on June 1, 2006.

FWCC was completely unaware of any problem with the Station only until it received a *Letter* from the Audio Division's James D. Bradshaw dated October 18, 2010, (copy *Letter* attached). Upon receipt, FWCC immediately contacted its FCC Counsel to look into this problem. Counsel has contact the Media Bureau Staff regarding this situation and has been advised to file this STA. Simultaneously with this STA Request, FWCC is submitting a Renewal of License Application together with a Petition for Reconsideration.

FWCC has had a long history of rule compliance and has operated in the public interest. Under the circumstance, FWCC again respectfully requests approval of this STA.


Dear Licensee:

The license for the above-referenced station expired on June 1, 2006. An application for renewal of this station's license should have been filed by February 1, 2006. To date, we have no record of receiving a license renewal application for this station, and the station's license has expired by its own terms.

Accordingly, all authority to operate station W208BC, Corning, NY IS TERMINATED and the call letters ARE DELETED. Any operation of this facility is now unauthorized and must cease immediately.

Finally, it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower be maintained until the tower is dismantled. Accordingly, the owner of the tower where the referenced station's transmitting antenna is located must maintain the tower in the manner prescribed by the Commission's rules and the terms of the expired license. See 47 U.S.C. Section 303(q) and 47 C.F.R. Section 17.6.
